SPECIAL EUROPEAN COUNCIL

- 1. The media reaction to the Rome European Council concentrated on the two IGCs, and UK isolation. The same theme is picked up today in the light of the Prime Minister's statement to the House.

Useful other European reactions on Rome

"The Prime Minister was quite right to condemn France for its obstructive attitude" (on GATT) (Liberation)

"With a country as important as the UK, the Twelve (SIC) will never lose patience" (Andreotti)

"It is never pleasant to see a partner isolated because at the end of the day no solution is possible without unanimous consent . . . to rejoice at seeing eleven countries agreed against one is demagogy . . . A useless summit and we will pay the consequences" (Santer, Luxembourg)

"The further one is from the realities, the easier the transition to a common [ie. single] currency appears" (Pöhl, FRG)

"By no means all bridges have been burnt between the UK and its partners" (Figaro, France)


"Setting a date before the content of Stage II is known is a pig in a poke" (Press comment, FRG)

"In spite of its reservations, the UK is prepared to take an active part in discussions rather than to isolate itself in a sterile sulk" (Le Monde)


