FALKLANDS: NON-ALIGNED MOVEMENT

1. THE COORDINATING BUREAU OF THE NON-ALIGNED MEETS AT FOREIGN MINISTER LEVEL IN HAVANA FROM 31 MAY TO 4 JUNE IN PREPARATION FOR THE NON-ALIGNED SUMMIT IN BAGHDAD IN SEPTEMBER. CUBA AND OTHER SUPPORTERS OF ARGENTINA ARE LIKELY TO ASK THE MEETING TO ISSUE A STATEMENT ENDORSING THE ARGENTINE POSITION AND CRITICISING OUR MILITARY ACTION. SUCH A STATEMENT COULD HAVE AN IMPORTANT IMPACT ON ANY FURTHER DEBATES AT THE UNITED NATIONS, WHETHER IN THE SECURITY COUNCIL OR IN THE GENERAL ASSEMBLY, WHICH COULD BE CALLED INTO EMERGENCY SPECIAL SESSION IF WE USE OUR VETO.

2. ACTION ADDRESSEES ARE IN COUNTRIES WHICH ARE MEMBERS OF THE COORDINATING BUREAU AND, EXCEPT FOR HAVANA, SHOULD TAKE ACTION AT A HIGH LEVEL TO PUT OVER THE POINTS IN PARAGRAPH

3 BELOW. HAVANA IS NOT ASKED TO TAKE ACTION WITH THE CUBANS BUT SHOULD DO WHATEVER IS POSSIBLE TO MONITOR THE PROCEEDINGS OF THE BUREAU AND TO KEEP IN TOUCH WITH FRIENDLY DELEGATIONS. NON-MEMBERS OF THE BUREAU ARE PERMITTED TO ATTEND COORDINATING BUREAU MEETINGS AND WITH THE SUMMIT COMING UP MANY MAY DO SO. INFORMATION ADDRESSEES SHOULD, UNLESS THEY SEE OBJECTION, ACCORDINGLY TAKE SIMILAR ACTION WITH THEIR HOST GOVERNMENTS WHERE THESE ARE TO BE REPRESENTED AT THE HAVANA MEETING.

3. POSTS ALREADY HAVE AMPLE GUIDANCE ON WHICH TO DRAW. FOR THE PURPOSE OF THE PRESENT REPRESENTATIONS, THE MAIN POINTS TO GET OVER ARE:

- A) ESSENTIAL FOR NAM TO CONDEMN ARGENTINA FOR RESORT TO FORCE:
- B) BRITAIN MUST NOT BE CRITICISED FOR RESORTING TO FORCE IN SELF-DEFENCE:
- C) NAM SHOULD CALL FOR IMMEDIATE IMPLEMENTATION OF SCR 502:
- D) REAFFIRMATION OF TRADITIONAL NAM SUPPORT (EG IN THE 1975 DECLARATION BY FOREIGN MINISTERS AT LIMA, THE 1976 COLOMBO DECLARATION BY HEADS OF GOVERNMENT AND THE 1981 NEW DELHI DECLARATION BY FOREIGN MINISTERS) FOR ARGENTINA'S POSITION ON SOVEREIGNTY WOULD BE INAPPROPRIATE AT THIS TIME AS IT WOULD GIVE AID AND COMFORT TO THE AGGRESSOR:
- E) THIS SUPPORT SHOULD IN ANY CASE BE RECONSIDERED IN THE LIGHT OF THE UN CHARTER PRINCIPLE OF THE SELF-DETERMINATION OF PEOPLES, WHICH ADMITS NO EXCEPTIONS:
- F) THERE SHOULD BE NO NAM CALL FOR DECOLONISATION OF THE ISLANDS UNLESS IT IS DIRECTED AT ARGENTINA.

POSTS SHOULD EMPHASISE THAT WE REGARD IT AS HIGHLY IMPORTANT THAT ANY NAM STATEMENT ON THIS OCCASION SHOULD BE IN SATISFACTORY TERMS AND THAT WE LOOK TO OUR FRIENDS TO MAKE A SPECIAL EFFORT IN HAVANA.

4. FOR YOUR BACKGROUND INFORMATION, ARGENTINA HAS SINCE 2 APRIL SECURED NAM OR G77 ENDORSEMENT FOR ONE-SIDED STATEMENTS IN A NUMBER OF UN ORGANS. THEIR METHODS HAVE BEEN UNSCRUPULOUS

AND HAVE AROUSED SOME RESENTMENT. NAM COUNTRIES FRIENDLY TO US SUCCEEDED IN MODERATING THE TWO MOST IMPORTANT OF THESE STATEMENTS, WHICH WERE ISSUED BY THE NAM COORDINATING BUREAU MEETING AT PERMANENT REPRESENTATIVE LEVEL IN NEW YORK ON 26 APRIL AND 5 MAY. THERE HAVE ALSO BEEN DECLARATIONS BY NAM MINISTERS OF HEALTH AT THE WORLD HEALTH ASSEMBLY IN GENEVA, AN NAM STATEMENT AT UNEP IN NAIROBI, AND A STATEMENT BY THE UNESCO G77 IN PARIS, WHICH IS LIKELY TO SURFACE AGAIN IN UNIDO IN VIENNA THIS WEEK. NONE OF THESE CRITICISED ARGENTINA'S RESORT TO FORCE AND MANY OF THEM FAILED TO MAKE ANY MENTION OF SCR 502. WE HAVE IN EACH CASE CIRCULATED COMPREHENSIVE STATEMENTS OF OUR OWN POSITION IN REPLY.

5. ACTION ADDRESSEES ACCREDITED TO MORE THAN ONE MEMBER OF THE COORDINATING BUREAU SHOULD ACT WHERE POSSIBLE WITH ALL, VIZ LAGOS ALSO WITH BENIN, ACCRA ALSO WITH TOGO, NEW DELHI ALSO WITH BHUTAN IF APPROPRIATE, AND KINSHASA ALSO WITH CONGO AND BURUNDI.
