1. FOLLOWING IS FREE TRANSLATION OF KEY PARAGRAPHS OF PORTUGUESE DEPUTY FOREIGN MINISTER'S LETTER TO ME OF 25 MAY:

BEGINS.

I HAVE PLEASURE IN CONFIRMING THAT THE PORTUGUESE GOVERNMENT, CONSCIOUS OF THE OVERRIDING INTERESTS OF THE ANGLO-PORTUGUESE ALLIANCE, HAS DECIDED TO GIVE ITS AGREEMENT IN PRINCIPLE TO THE REQUEST FORMULATED BY HMG THROUGH YOU, AFTER DULY CONSIDERING THE CONSEQUENCES WHICH SUCH A SERIOUS STEP WILL HAVE FOR PORTUGAL. THE DETAILED REQUESTS SHOULD BE MADE THROUGH THE DIPLOMATIC CHANNEL FOR APPRECIATION CASE BY CASE.

IT IS THE CONVICTION OF THE PORTUGUESE GOVERNMENT THAT HMG

FOR ITS PART WILL KNOW HOW TO ASSESS WHAT THIS ATTITUDE
REPRESENTS IN TERMS OF PORTUGUESE SOLIDARITY WITH THE UK.
THE PORTUGUESE GOVERNMENT THEREFORE IS CONFIDENT HMG WILL KNOW
HOW TO RESPOND WITH THE SAME SPIRIT IN WHICH THE PORTUGUESE
DECISION WAS TAKEN.
