FOLLOWING IS TEXT OF ARGENTINE DRAFT RESOLUTION CIRCULATING AT UN TODAY.

''THE GENERAL ASSEMBLY,

HAVING CONSIDERED THE QUESTION OF THE FALKLANDS ISLANDS (MALVINAS) AND HAVING RECEIVED THE REPORT OF THE SECRETARY-GENERAL.

AWARE OF THE INTEREST OF THE INTERNATIONAL COMMUNITY IN THE PEACEFUL AND DEFINITIVE SETTLEMENT BY THE GOVERNMENTS OF ARGENTINA AND THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND OF ALL THEIR DIFFERENCES, IN ACCORDANCE WITH THE UNITED NATIONS CHARTER,

TAKING NOTE OF THE INTEREST REPEATEDLY EXPRESSED BY BOTH PARTIES IN NORMALIZING THEIR RELATIONS,

CONVINCED THAT SUCH PURPOSE WOULD BE FACILITATED BY A GLOBAL NEGOTIATION BETWEEN BOTH GOVERNMENTS THAT WILL ALLOW THEM TO REBUILD MUTUAL CONFIDENCE ON SOLID BASIS AND TO RESOLVE THE PENDING PROBLEMS, INCLUDING ALL ASPECTS ON THE FUTURE OF THE FALKLAND ISLANDS (MALVINAS),

1. REQUESTS THE GOVERNMENTS OF ARGENTINA AND THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND TO INITIATE NEGOTIATIONS WITH A VIEW TO FIND THE MEANS TO RESOLVE PEACE-FULLY AND DEFINITIVELY THE PENDING PROBLEMS BETWEEN BOTH COUNTRIES, INCLUDING ALL ASPECTS ON THE FUTURE OF THE FALKLAND ISLANDS (MALVINAS), IN ACCORDANCE WITH THE UNITED NATIONS CHARTER: CONFIDENTIAL

- 2. REQUESTS THE SECRETARY-GENERAL TO CONTINUE HIS RENEWED MISSION OF GOOD OFFICES IN ORDER TO ASSIST THE PARTIES IN COMPLYING WITH THE REQUEST MADE IN PARAGRAPH 1 ABOVE, AND TO TAKE THE NECESSARY MEASURES TO THAT END:
- 3. REQUESTS THE SECRETARY-GENERAL TO SUBMIT A REPORT TO THE GENERAL ASSEMBLY AT ITS FORTY FIRST SESSION ON THE PROGRESS MADE IN THE IMPLMENTATION OF THE PRESENT RESOLUTION:
- 4. DECIDES TO INCLUDE IN THE PROVISIONAL AGENDA OF ITS FORTY FIRST SESSION THE ITEM ENTITLED ''QUESTION OF THE FALKLAND ISLANDS (MALVINAS)''.
