(YOU DO NOT GIVE US THE TEXT, ALTHOUGH THE SAG WILL HAVE ONE MORE CAUSE FOR COMPLAINT IF THEY RECEIVE NO ADVANCE NOTICE OF THE STATEMENT COMPLAINT IF THEY RECEIVE NO ADVANCE NOTICE OF THE STATEMENT ITSELF, ONLY THE LIST OF NAMES PLUS COMMONWEALTH ACCORD AS INTENDED AT PRESENT).

AGAIN, HAS RAMPHAL ANY IDEA OF THE FIERCELY LOW OPINION IN WHICH FRASER IS HELD HERE BY THE GREAT MAJORITY OF WHITES AS A RESULT OF STATEMNETS HE MADE AFTER VISITING SOUTH AFRICA EARLIER THIS YEAR ? IN ANY CASE I WONDER IF WE MIGHT NOT ARGUE THAT THE CHOICE OF CHAIRMAN OR CO-CHAIRMAN SHOULD BE A MATTER FOR THE GROUP THEMSELVES TO DECIDE.
