MY TELNO 2494: US/SOUTH AFRICA SUMMARY

- 1. SENATE OVERRIDES PRESIDENT'S VETO. SANCTIONS BILL NOW US LAW. DETAIL
- 2. ON 2 OCTOBER THE SENATE VOTED 78-21 TO OVERRIDE THE PRESIDENT'S VETO OF THE SANCTIONS BILL, THUS EASILY EXCEEDING THE REQUIRED TWO-THIRDS MAJORITY. SINCE THE HOUSE HAD ALREADY VOTED OVERWHELMINGLY FOR THE OVERRIDE (MY TELNO '2480) THE SANCTIONS BILL NOW BECOMES LAW, DESPITE THE PRESIDENT'S VETO.
- 3. THE OUTCOME HAD NEVER BEEN SERIOUSLY IN DOUBT SINCE THE 26 SEPTEMBER DECISION THAT THE VETO SHOULD NOT BE COUPLED WITH AN IMMEDIATE EXECUTIVE ORDER (MY TEL NO 2465). THE MARGIN OF DEFEAT IN THE SENATE (13 VOTES SHORT OF THE 34 NEEDED TO SUSTAIN A VETO) WAS WIDER THAN EXPECTED. ONE FACTOR WHICH PROBABLY INFLUENCED THE VOTE IN AN UNHELPFUL WAY FROM ADMINISTRATION'S POINT OF VIEW WAS PIK BOTHA'S TELEPHONE CALLS PRETORIA TELNO 345). SENATORS OBJECTED STRONGLY TO THE INPLIED THREAT IN BOTHA'S MESSAGE, ONE SENATOR TO WHOM BOTHA SPOKE DESCRIBED IT AS TANTAMOUNT TO BLACKMAIL.
- 4. THE PRESIDENT HAD LOBBIED PERSONALLY, THOUGH RATHER LATE IN THE DAY, AGAINST THE OVERRIDE, AND THIS DEFEAT AT THE HANDS OF CONGRESS (THE FIRST VETO OVERRIDE OF THIS ADMINISTRATION ON A MAJOR FOREIGN POLICY MATTER - THOUGH THERE HAVE BEEN SEVERAL OTHERS ON LESS IMPORTANT ISSUES) IS A SIGNIFICANT SETBACK FOR HIM. NEVERTHELESS, PERHAPS BECAUSE HE WAS ALL ALONG CONSCIOUS OF THE PROBABILITY OF DEFEAT ON AN ISSUE ON WHICH CONGRESS HAD CAPTURED

THE HIGH MORAL GROUND, HE NEVER SEEMED TO ENGAGE HIS FULL PRESTIGE IN THE SANCTIONS BATTLE (AS HE DID, FOR EXAMPLE, IN THE CONTRA AID BATTLE, WHICH HE WON). THE DEFEAT IS CORRESPONDINGLY LESS DAMAGING: AND BECAUSE IT WAS LARGELY DISCOUNTED, AND COMES ALMOST AT THE END OF THE SESSION, WILL HAVE LITTLE IMMEDIATE EFFECT ON THE PRESIDENT'S DEALINGS WITH CONGRESS ON OTHER ISSUES.
