THEY ALSO PROPOSE THAT: - TALKS BE PREFACED BY A JOHNT STATEMENT RESERVANG RESPECTIVE POSHITHONS ON SOVERENGNTY .

- EACH SHIDE SHOULD MAKE STATEMENTS AND AT CREATING A FAVOURABLE ATMOSPHERE.

- 2. THUS IS A CLEAR DEPARTURE FROM ARGENTANA'S EARLHER HARD LINE.
 THERE ARE A NUMBER OF POSSUBLE EXPLANATIONS:
 - ARGENTH-NE RECOGNECTION THAT THE RESULT OF OUR ELECTIONS MEANS THAT THERE WILL BE NO CHANGE IN BRIETHISH POLICY!
 - PRESSURE FROM THE AMERICANS:
- DESIRE FOR A QUOTE SUCCESSFUL FOREIGN POLICY INFIDIATIVE UNQUOTE BEFORE ARGENTHINA'S ELECTRONS IN SEPTEMBER. WHATEVER ALFONSIAN'S MOTIVES FOR LAUNCHING THIS MOVE, WE HAVE NO

EVEDENCE THAT ARGENTANE POLICY WHLL PROVE MORE FLEXIBLE THAN BEFORE OR THAT HAS DOMESTIC ROOM FOR MANDEUVRE ON THE SOVEREIGHTY USSUE IS ANY GREATER. NEVERTHELESS, HE NOW APPEARS TO BE PROPOSING WHAT WE HAVE ALWAYS INSUSTED UPON, DIRECT TALKS ON PRACTICAL MATTERS, UNLINKED TO ANY DISCUSSION OF SOVEREIGHTY.

- 3. WE MUST NOT GIVE THE IMPRESSION TO THE AMERICANS, OR TO ANYONE ELSE, THAT WE NOW WANT TO REJECT OUR OWN TERMS. WE SHOULD HOWEVER RESPOND WITH CONSIDERABLE CAUTION. THE SUBSTANCE IS AS INTRACTABLE AS EVER. THE ARGENTINES REMAIN ATTACHED TO RHETORIC, AND WILL PROBABLY AGAIN EXPLOIT THE ANNUAL UNGA DEBATE. SO WE CANNOT BY ANY MEANS BE SURE THAT REAL PROGRESS WILL BE MADE.
- 4. HAN OUR RESPONSE WE MUST ABOVE ALL ENSURE THAT THERE HAS TO BE NO DESCUSSION OF SOVEREHONTY, AND THAT THE ARGENTHINES UNDERSTAND AND ACCEPT THES. SUBJECT TO THAT, OUR OBJECTHIVES SHOULD BE:
- (A) TO SECURE ARGENTANE ACCEPTANCE OF OUR FASHERMES JURASDACTION:
- (B) HF (A) HS ACHHEVED, TO MAKE PROGRESS ON OTHER PRACTICAL ASSUES:
- (C) TO REASSURE THE HISLANDERS THAT SUCH TALKS WHITH THE ARGENTHINES CARRY NO RHISKS ON SOVEREMENTY OR FRISHERMES JURNISDINGTHON: AND

(D) TO MAKE SURE THAT THE ARGENTHNES ARE SEEN AS RESPONSIBLE MF THIS PROCESS COMES TO NOTHING.

(A) WOULD BE A MAJOR GAMN. WE SHOULD HOWEVER RECOGNISE THAT A CONSEQUENCE OF ANY AGREEMENT WOULD BE TO HAMPOSE SOME CONSTRAINT ON OUR FREEDON OF ACTION, EG TO EXTEND THE BOUNDARIES OF THE FINCZ HF WE THOUGHT THAT NECESSARY FOR CONSERVATION REASONS, BECAUSE OF THE PRESSURE NOT TO UNDERMINE THE SPERIET OF ANY UNDERSTANDING ON FORSHERIES. THERE COULD ALSO BE RENEWED ARGENTIONE PRESSURE FOR THE THE FILPZ ON EXCHANGE FOR A CESSATION OF HOSTOCIOTICO. THESE CONSEQUENCES ARE HOWEVER HINHERENT OF ANY AGREEMENT ON THOSE SUBJECT, AND WE HAVE ALWAYS MAINTAINED THAT WE WANT SUCH A AGREEMENT: THEY DO NOT THEREFORE JUSTIFY REJECTIONS THE OFFER OF DIALOGUE. ON ANY NEGOTIONATIONS WE WOULD MAKE SURE FORMALLY TO PRESERVE UNIMPARTED OUR FREEDOM TO EXERCISE OUR OWN SOVEREIGNTY AND JURNSDICTION. ON CESSATION OF HOSTOCIOTICS, WE CAN CONTINUE TO TAKE THE LIFE THAT A FIRSHERIES AGREEMENT WOULD BE ONLY ONE OF THE FACTORS FOR CONSIDERING THE FUTURE OF THE FIRPZ.

- 5. SOME FEATURES OF THE SARGENTHE APPROACH ARE UNREALESTAC. FOR EXAMPLE, TO PROPOSE OPTIMENTAL STATEMENTS BEFORE THE SUBSTANCE AS REACHED WOULD INVESTE A REPETITION OF THE BERNE FRASCO. OF THESE ADEAS ARE PURSUED, WE SHALL NEED FORMLY TO RESEST THEM, AS PART OF THE PROCESS OF EDUCATING THE ARGENTHES ABOUT REALISTY. HE REPLYING WE SHOULD THEREFORE STRESS THAT WE SEE THE FREST PROPERTY AS AGREEMENT ON FASHERIES, WHITH DESCUSSION OF OTHER PRACTICAL ISSUES TO FOLLOW. FOR THAT REASON THE ESSENTIFAL BASIS OF ANY NEGOTIFATIONS WOULD BE A CLEAR UNDERSTANDING OF THE WATERS TO BE PATROLLED BY EACH SIDE. WE NEED TO MAKE OUR POSITION CLEAR AN ADVANCE ON THESE POINT, NOT LEAST BECAUSE THE ARGENTHINES HAVE HAD AN MIND THE UNACCEPTABLE NOTION OF SHARED FUSHERIES JURISDICTION OVER FALKLANDS WATERS.
- 6. THE ARGNTHNE FORMULA FOR RESERVING POSITIONS ON SOVEREIGNTY HS ACCEPTBALE, WITH ONE OR TWO MINOR MODIFICATIONS. HT HS DERINED FROM THE ANTARCTIC TREATY AND THE CONVENTION ON THE CONSERVATION OF ANTITARCTIC MARRINE LINVING RESOURCES (CCAMLR) TEXTS, WHICH HAVE EFFECTIVELY PRESERVED OUR SOVEREIGNTY POSITION. THE ATTORNEY GENERAL HS CONTECT THAT THEY WOULD ADEQUATELY PROTECT OUR LEVAL POSITION.
- 7. A ATTACH DRAFT WASTRUCTHONS TO SHR ANTONY ACLAND ON THESE LINES. AT THE SAME THME W WOULD MASTRUCT THE ACTHING GOVERNOR ON PORT STANLEY TO BRENE HIS EXECUTIVE COUNCIL THOROUGHLY AND MIN CONFIDENCE. WE WE OBTAIN ARGENTINE UNDERTAKING ON THE POINTS ON THIS NON-PAPER, THE WAY AHEAD WOULD THEN BE CLEAR.

BETHE RHSK OF LEAKS FROM BUENOS AMES, AND THE NEED TO KEEP THE AMERICANS ON OUR SHIDE, ARGUE HIN FAVOUR OF AN EARLY REPLY. THES WOULD AVOID ANY CRETELCHISM OF US FOR DRAGGING OUR FEET, AND WOULD PUT THE ONUS OF DECH-SHON BACK WHITH THE MAGENTANES BEFORE THE SUMMER BREAK. N. SHOULD THEREFORE BE MOST GRATEFUL HE COLLEAGUES COULD SEND THEME COMMENTS TO ME HAN THE COURSE OF THE NEXT FEW DAYS. UNQUOTE.
