- PLEASE SEE MY IPT. (68)
- AS I REACHED THE LAST PHRASE IN PARAGRAPH 2 OF YOUR TUR YESTERDAY EVENING CAVANDOLI BROKE IN TO SAY THAT HE ALREADY HAD JUNTA CLEARANCE FOR THE IDEA OF SEEKING A SOLUTION ON THE BASIS OF SOLIPSISM. HE CONCEDED THAT HE HAD NOT MADE THIS GOOD NEWS CLEAR TO YOU BOTH OR TO ME EARLIER, BUT SAID THAT THIS WAS, IN FACT WHAT REMARKS REPORTED IN THE LAST SENTENCE IN PARAGRAPH 2 OF LYNE'S RECORD OF 25 SEPTEMBER WERE INTENDED TO CONVEY. I WENT OVER THE MATTER CAREFULLY SEVERAL TIMES WITH HIM AND RE-CHECKED IN ENGLISH WITH HIS TRAVELLING COMPANION AT AT RECEPTION LATER TO MAKE SURE THAT THERE IS NO MISUNDERSTANDING, BUT THAT ARGENTINES HAVE, IN FACT, ALREADY JUMPED THEIR HURDLE.
