STATEMENT

Lord Carrington in the Lords (2.50pm) and Mr Luce in the Commons (3.30pm) will make Statements on the current situation and diplomatic moves over South Georgia. No particular announcement, simply a desire to keep the House informed - and Lord Carrington would obviously prefer to do this himself. There was a great deal of interest being shown in the situation and the most important European Council business had been covered the day before.

MEETING WITH HAUGHEY

In response to a question we confirmed that the PM had seen Mr Haughey for about 20 minutes in Brussels this morning at his request. They discussed the economic and social affairs raised at the European Council yesterday. Northern Ireland was not touched on though there was a passing reference to tomorrow's meeting between Mr Prior and Mr Collins, the Irish Foreign Minister. Asked if they had discussed the implications for the Irish Republic of reduced budget contributions from Britain we said we understood the Budget/Mandate question had not been an issue in their conversation.

HMS ENDURANCE

Asked about stories of a "reprieve" for HMS Endurance we said nothing to this effect had been announced and we saw no indication of it. However we reminded the lobby that the Lord President in his latest briefing had made it clear that the House would have a further opportunity to discuss the future of HMS Endurance.
