### OPERATION CORPORATE

### ITEM 1. INTELLIGENCE MATTERS

- 1. SIR TERENCE LEWIN invited the Deputy Chief of the Defence Staff (Intelligence) to update them on the current situation in the Falkland Islands and South Georgia.
- 2. LIEUTENANT GENERAL GLOVER (Deputy Chief of the Defence Staff (Intelligence)) outlined the probable disposition of Argentine forces and significant merchant ships in and around the Falkland Islands and the Argentine mainland. He also reported the likely establishment of an Argentine Atlantic Theatre of Command with a 3-star commander. Turning to the situation in Chile, he said the outcome of the meeting between the President and his Commanders-in-Chief, mentioned in his intelligence report (1) the previous day, was not yet known but 2 Chilean destroyers each with a Marine infantry company on board were reported to be moving South.
- 3. AIR VICE-MARSHAL ARMITAGE (Director of Service Intelligence) then briefed the Committee on the airfield in the Falkland Islands and said that a detailed brief would be circulated for the Committee's information.

4. MR WRIGHT (Foreign and Commonwealth Office) said that as far as refuelling of ships was concerned Portugal and Senegal were unlikely to refuse facilities but there was less assurance in respect of the Cape Verde Islands. He also said that Panama was unlikely to deny transit of the Panama Canal to RFA TIDEPOOL.

- 5. In discussion the following points were made:
  - a. A small number of Argentine Super Etendard aircraft were believed to be equipped with the air-launched version of the Exocet anti-ship missile. More information was needed on the potential of these aircraft in operations against the Task Force.
  - b. France had undertaken to stop supplying military equipment to Argentina from 15 April.
  - c. The Argentines could in time improve the airfield at Port Stanley for operations by Mirage and Skyhawk air defence aircraft as well as by transport aircraft. Air defence operations would likely be in daytime only in good visibility; lack of fuel supplies could be a further limitation; and aircraft on the ground would be vulnerable to attack.
  - d. Fuel and other supplies to the Argentine forces in the Falkland Islands would be carried mainly by merchant ship or naval auxiliary. This sea line of communication could be interrupted by the imposition of an Exclusion Zone and appropriate Rules of Engagement for our forces.
  - e. A further assessment was required of the size of force that Argentina could sustain in the Falkland Islands, taking account of developments since the invasion and the problems of providing suitable accommodation.
  - f. Refuelling our naval auxiliaries and ships taken up from trade in friendly countries should not be publicised. However, refuelling at Gibraltar would inevitably become widely known.
- 6. Summing up, SIR TERENCE LEWIN said they would wish to instruct the Deputy Chief of the Defence Staff (Intelligence) to provide an assessment of the capability of the Super Etendard and a further assessment of the size of Argentine force that could be sustained in the Falkland Islands. They would take note that the Foreign and Commonwealth Office would put to Ministers the question of publicity for refuelling arrangements.

# ITEM 2. DEFENCE AND OVERSEA POLICY SUB-COMMITTEE ON SOUTH AMERICA (OD(SA)) DEBRIEF

- 7. SIR TERENCE LEWIN briefed the Committee on the meeting of OD(SA) that morning. Particular points were:
  - a. Agreement was taken in principle on an Exclusion Zone of 200 miles radius to be centred on the Falkland Islands.
  - b. Ministers had agreed that the recapture of South Georgia was a military option, for which planning should be carried out.
  - c. The Prime Minister well understood the need to issue orders to HMS SPARTAN by late 8 April if the implementation of the Exclusion Zone was not to be delayed after Monday 12 April.

### ITEM 3. INSTRUCTIONS TO OVERSEAS REPRESENTATIVES

- 8. AIR VICE-MARSHAL GILBERT (Assistant Chief of the Defence Staff (Policy)) said that a statement was being prepared for our diplomatic and military representatives overseas to have as background for their dealings with colleagues. Head of British Defence Staff Washington would be visiting London the following day, in which case he would brief him personally.
- 9. In discussion the following points were made:
  - a. The Defence Secretariat and the Foreign and Commonwealth Office were arranging for suitable advice to be provided to the UK Permanent Representative to the North Atlantic Council.
  - b. In formulating advice to overseas representatives care should be taken not to indicate our perception of Argentine strengths, and to give only the titles of our own units without giving details of strength, capability or plans.
  - c. The Secretary of State had agreed that in the forthcoming parliamentary debate on the Falkland Islands, it would be desirable for Ministers to avoid mentioning detailed assessments of strengths and capabilities.

### ITEM 4. SIGNAL TO MILITARY COMMANDERS

10. SIR TERENCE LEWIN said that the Secretary of State had approved the text of a signal which he intended to send to Military Commanders, setting out the aim of Operation CORPORATE.

### ITEM 5. AMPHIBIOUS OPERATIONS APPRECIATION

- 11. SIR EDWIN BRAMALL said there now appeared to be a gap in their examination of options for operations against the Argentine forces. A detailed appreciation of the options for amphibious operations against the Falkland Islands was required, as soon as possible for their consideration.
- 12. Summing up a short discussion SIR TERENCE LEWIN said they would wish to go into this matter thoroughly at their meeting the next day.

### ITEM 6. PUBLIC RELATIONS

- 13. SIR EDWIN BRAMALL asked the Permanent Under Secretary of State whether he was happy with the resources available in the Ministry of Defence for Public Relations. He was prepared to agree to a re-allocation of responsibilities for the Director of Public Relations (Army)'s staff if that would assist.
- 14. SIR FRANK COOPER (Permanent Under Secretary of State) said that the lack of a Chief of Public Relations (CPR) had placed a heavy load on the Deputy Chief (DCPR). A new CPR would take up his appointment next week and assume responsibilities for all matters except Operation CORPORATE which would remain with the DCPR. He thanked the Chief of the General Staff for his offer.

### ITEM 7. TACTICAL NUCLEAR WEAPONS

- 15. SIR HENRY LEACH asked whether any change of policy concerning tactical nuclear weapons was likely.
- 16. SIR TERENCE LEWIN said that this had been discussed at the OD(SA) meeting earlier that day. A Ministerial statement was expected shortly to the effect that, while there was no possibility that nuclear weapons would be used against Argentine territory or their forces in the Falkland Islands
