OPERATION CORPORATE

ITEM 1. INTELLIGENCE

- 1. SIR TERENCE LEWIN invited the Deputy Chief of the Defence Staff (Intelligence) to update them on current intelligence.
- 2. LIEUTENANT GENERAL GLOVER (Deputy Chief of the Defence Staff (Intelligence)) reviewed the intelligence published in the latest summary (1). He said a meeting had been arranged with representatives of Aerospatiale that afternoon to obtain details of the overseas sales of EXOCET, particularly with regard to Peru and South Africa. He also said there was no intelligence of any resupply of the Falkland Islands by air or sea having taken place since the Total Exclusion Zone had been enforced.
- 3. Summing up, SIR TERENCE LEWIN said he wished the Deputy Chief of the Defence Staff (Intelligence) to give him, that afternoon, details of the shipping remaining in Port Stanley harbour, and its carrying capacity, as this would be relevant in any future discussions on the withdrawal of Argentine troops from the Islands.

ITEM 2. OWN FORCES

- 4. The Task Force Organisation was set out in the Force Tote Sitrep (2).
- 5. The operations of the previous 24 hours had been summarised in the television briefing preceding their meeting.
- 6. SIR HENRY LEACH said he would make available daily to the Chiefs of Staff a chart showing the approximate positions of our SSNs in relation to the assessed positions of Argentine ships.

ITEM 3. PUBLIC RELATIONS

- 7. AIR COMMODORE MILLER (representing the Deputy Chief of Public Relations) reported on press coverage. He said that arrangements had already been made for any interviews with survivors from HMS SHEFFIELD to be selective, and to be subjected to MOD scrutiny before release.
- 8. Summing up a short discussion, SIR TERENCE LEWIN said they would wish to agree that he should discuss with the Chief of the Naval Staff and the Permanent Under Secretary the best way of countering the speculation that the attack on HMS SHEFFIELD had exposed a fatal flaw in our naval defences.

ITEM 4. ACTIONS AND DECISIONS REQUIRED.

9. The Committee noted the summary of Actions in Hand (3).

ITEM 5. MILITARY OPTIONS

- 10. The Committee had before them a paper (4) setting out the military options for Operation CORPORATE. In discussion it was agreed that the paper now met their requirements, although it needed some factual amendment. It would be useful to keep it regularly updated in case it was required in future discussions with Ministers. However, if action to take up any particular option included in the list was contemplated, a very much more thorough and detailed examination of that option would be needed.
- 11. Summing up, SIR TERENCE LEWIN said they would wish to instruct their staffs to forward detailed amendments to the paper to the Defence Policy Staff, and to instruct the Assistant Chief of the Defence Staff (Policy) to revise the paper weekly and present it for their consideration each Thursday.

ITEM 6. CONCEPT OF OPERATIONS

12. SIR MICHAEL BEETHAM said he was concerned that they had still not been informed of the concept of operations on which the Task Force Commander was basing his operational plans. He had no wish to interfere with the detailed planning and execution of daily operations, but he considered that the Chiefs of Staff could not advise Ministers unless they knew the overall concept.

He considered the concept should include such aspects as the general method of enforcing the Total Exclusion Zone taking into account the range of land-based Super Etendard aircraft, the operational radius of action of Sea Harrier aircraft and the means by which we could gain early warning of enemy activities; the overall requirements for Special Forces Operations; and the requirements for harassing operations. Finally, he pointed out that they had not yet been given the concept for follow-up operations to an initial landing, which they had invited (5) the Task Force Commander to prepare.

13. Summing up a short discussion, SIR TERENCE LEWIN said he was meeting the Task Force Commander that evening, and would discuss with him his concept of operations; he would report to them the next day. He said Ministers would probably require during the following week a briefing on landing operations, which would need to include an assessment of the options and timing factors for Operation SUTTON, as they had previously agreed (5); in his discussion with the Task Force Commander he would determine whether the latter had yet obtained sufficient tactical intelligence upon which to make that assessment.

ITEM 7. RULES OF ENGAGEMENT

- 14. SIR HENRY LEACH informed the Committee that his staff were preparing a revised set of Rules of Engagement for Operation CORPORATE, drawing together the various packages of rules which had previously been agreed. He proposed to circulate this revision (6) for their agreement out of committee that day, prior to its submission to the Secretary of State. He also said that the Task Force Commander intended to recommend Rules of Engagement for use by surface ships not included in the Carrier Battle Group against Argentine civilian aircraft carrying out surveillance operations.
- 15. SIR TERENCE LEWIN said they would note the Chief of the Naval Staff's intentions. He advised that the new proposals should be scrutinised by OD(SA) Senior Officials before being submitted to the Secretary of State.
- 16. He also said they would wish to instruct the Assistant Chief of the Defence Staff (Operations) to confirm with the Foreign and Commonwealth Office their agreement to the revised geographic limits to SSN Rules of Engagement put forward at OD(SA) that morning, before ordering the Task Force Commander to implement them.

The purpose of this declaration would be to make Royal Fleet Auxiliary and Merchant Service personnel subject to the Naval Discipline Act.
