2. The statement is not very forthcoming. On US assistance, this is because the US still remain very nervous about making any details public. See Washington Tel No 1854 attached. Nonetheless, as predicted leaks are beginning to appear from US sources. See para 4 of Washington Tel No 1850 attached. I suggest that PUS should confirm that the US are being helpful, but only on a strictly unattributable basis.

WHAT ASSISTANCE HAS THE US OFFERED?

Primarily, the assistance what we have sought from the US merely involves the replenishment of existing stocks of equipment which we have purchased in the past from the United States. They are also providing some direct logistic assistance (KC 135 tankers) in the UK. We have no intention of requesting direct US military support in the Falklands area. The United States has responded sympathetically to our requests, as Secretary Haig promised on 30 April. We are most grateful for the efforts which have been made to accelerate delivery of equipment to us. Cannot go into details of what is involved, but lt includes a range of equipolation and other support. it includes a range of equipment.

FALKLANDS

1. HAIG TOLD ME THIS AFTERNOON THAT THE US EMBASSY IN BUENOS AIRES HAD JUST REPORTED THAT THE ARGENTINES WERE TALKING OF BREAKING OFF RELATIONS WITH THE US. ONE PRETEXT BEING ADVANCED WAS US MATERIEL SUPPORT FOR BRITAIN AND THE DETAILED PUBLICITY GIVEN TO IT IN THE AMERICAN PRESS. HAIG SAID THAT IN THIS CONTEXT NEWSPAPER REPORTS SUCH AS THAT WHICH APPEARED IN TODAY!S NEW YORK TIMES (MY TELNO 1840) - WHICH OF COURSE CAME FROM US SOURCES - WERE MOST UNHELPFUL. HE HOPED WE WOULD CONTINUE TO AVOID MAKING PUBLIC DETAILS OF THE SUPPORT WE WERE GETTING. HE ALSO REFERRED TO THE STATEMENT ISSUED BY THE WHITE HOUSE TODAY (SEE MIFT).

PRESS LEAD WITH THE PRIME MINISTER!S DESCRIPTION OF OUR NEGOTIATING POSITION, REPRESENTING THE LIMITS TO WHICH THE GOVERNMENT BELIEVED IT RIGHT TO GO: AND HER STATEMENT THAT SINCE THESE PROPOSALS HAD BEEN REJECTED THEY WERE NO LONGER ON THE TABLE THE PAPERS NOTE THAT HMG!S PROPOSALS WERE SUPPORTED BY ALL PARTIES IN THE HOUSE OF COMMONS AND THAT THE OPPOSITION SUPPORTED THE USE OF FORCE IF THEY WERE NOT ACCEPTED, WHILE ARGUING THAT EFFORTS SHOULD

STILL BE MADE TO KEEP NEGOTIATING CHANNELS OPEN.

- 2: THE OTHER LEAD ITEM IS THE UN SECRETARY GENERALIS CONCLUSION THAT HIS MEGOTIATING INITIATIVE MAS AT AN END. THE MEW YORK TIMES AND THE MASHINGTON POST IDENTIFY THE MAIN POINTS OF DIFFICULTY AS ARGENTINE INSISTENCE ON THE WINNING OF SOVEREIGNTY IN DUE COURSE: OUR DETERMINATION TO ENSURE THAT THE ISLANDERS WERE ASSOCIATED WITH THE INTERIM ADMINISTRATION AND THAT ACCOUNT WAS TAKEN OF THEIR MISHES: AND THE ARGUMENT OVER THE INCLUSION OF THE DEPENDENCIES. THE GENERAL CONCLUSION DRAWN IS THAT MATTERS WILL NOW BE DECIDED BY MILITARY ACTION OVER THE NEXT FEW DAYS.
- 3. A REPORT FROM BUEHOS AIRES IN THE WASHINGTON POST QUOTES ARGENTINE OFFICIALS AS STATING THAT THE TWO SIDES REMAINED ALMOST AS FAR APART AS AT THE BEGINNING OF THE CRISIS: THAT ARGENTINA NEVER MODIFIED ITS POSITION THAT ANY AGREEMENT HAD TO LEAD AT LEAST IMPLICITLY TO ARGENTINE SOVEREIGNTY AND HAD PROPOSED THAT NO PROVISION SHOULD BE MADE FOR GOVERNING THE ISLANDS AFTER 31 DECEMBER THIS YEAR AS ARGENTINA HAD INTENDED TO TAKE OVER THE ISLANDS ONCE AGAIN IF THERE WERE NO AGREEMENT BY THAT DATE. THIS POSITION IS JUSTIFIED BY THE SUPPOSED NEED TO QUOTE FORCE THE BRITISH TO NEGOTIATE UNDER THEIR PROPOSAL THEY COULD HAVE KEPT ON NEGOTIATING FOR ANOTHER 150 YEARS UNQUOTE.
- 4. THE NEW YORK TIMES QUOTING ADMINISTRATION OFFICIALS GIVES A CIRCUMSTANTIAL ACCOUNT OF THE MATERIAL ASSISTANCE BEING PROVIDED

HE UNITED STATES. THE US IS SAID TO BE MAKING AVAILABLE SEVERAL AERIAL TANKERS FOR OPERATIONS IN THE NORTH ATLANTIC, TO PENSATE FOR THE VICTORS REQUIRED TO REFUEL VULCANS AND MINRODS ASCENSION ISLAND. THE US IS ALSO FURNISHING INFORMATION ON REAPONS SOLD TO ARGENTINA AND HAS EARMARKED FOR TRANSFER TO BRITAIN SURFACE TO AIR MISSILES AND RADAR FOR USE BY BRITISH FORCES ON THE FALKLANDS, THE ITEMS WERE IDENTIFIED FOR RAPID SHIPMENT TO ASCENSION ISLAND WHERE THEY COULD BE TRANSFERRED TO THE TASK FORCE. THE CONTINGENCY LIST ALSO INCLUDS ENGINEERING EQUIPMENT, HEATERS, GENERATORS, AMMUNITION AND PORTABLE TANKS TO

5. AN EDITORIAL IN YESTERDAYS EALTIMORE SUN DEPLORES THE NATIONALISM BEING DISPLAYED BY BOTH COUNTRIES: MOST WARS AFE STUPID AND UNJUSTIFIED, AND THE FALKLANDS STRUGGLE MORE THAN MOST. EDITORIALS TODAY IN THE WASHINGTON POST AND BALTIMORE SUN COMMENT ON THE RELUCTANT AND PARTIAL RENEWAL OF EC SANCTIONS (THE POST CRITICISES THIS AS A REMARKABLY UNHELPFUL GESTURE WHICH, IF INTENDED TO DISSUADE BRITAIN FROM FURTHER ACTION WILL ALSO HAVE BEEN A FAILURE), THE FAILURE TO AGREE A BUDGET REPATE AND THE MAJORITY VOTE ON FARM PRICES.
