# ITEM 1. INTELLIGENCE

- 1. SIR TERENCE LEWIN invited the Deputy Chief of the Defence Staff (Intelligence) to update them on current intelligence.
- 2. LIEUTENANT GENERAL GLOVER (Deputy Chief of the Defence Staff (Intelligence)) reviewed the intelligence published in the latest summary (1). He assessed Argentine naval dispositions and intentions, and Argentine air force losses and remaining capability. He said it was now known that there was a daily civilian Hercules flight from Peru to Buenos Aires carrying military spares and equipment from Israeli sources.
- 3. Summing up a short discussion, SIR TERENCE LEWIN instructed the Assistant Chief of the Defence Staff (Operations) to arrange for the Guardship to establish the identity and purpose of the merchant ship which had apparently broken down 80nm off Ascension Island. He also instructed the Deputy Chief of the Defence Staff (Intelligence) to determine and report to them the next day the rate of Lloyds insurance premium being applied to merchant shipping in the South Atlantic. Finally he instructed the Deputy Chief of the Defence Staff (Intelligence) to brief them on Friday 28 May on the problems of acquiring early warning of Argentine air attacks on the Task Force.

# ITEM 2. OWN FORCES

- 4. REAR-ADMIRAL BROWN (Assistant Chief of the Defence Staff (Operations)) outlined the deployment and operations of the Task Force.
- 5. Summing up a short discussion, SIR TERENCE LEWIN said he would discuss with the Task Force Commander whether there were over-riding security objections to the Secretary

of State announcing the number of additional warships which had now joined the Task Force. To enable him to brief the Secretary of State, he would also clarify with the Task Force Commander the general area in which the Carrier Battle Group operated, in relation to the radius of action of its Harrier aircraft and its vulnerability to attack by land based Argentine aircraft.

# ITEM 3. PUBLIC RELATIONS

- 6. MR McDONALD (Deputy Chief of Public Relations) reported on press coverage.
- 7. SIR HENRY LEACH said he was concerned at the general impression which had been created in the past few days by the release of bad news by the Ministry of Defence. He did not wish to suppress bad news, but believed it should be placed in context of the operation as a whole. The aim of the operation had been to secure a bridgehead; this had been achieved without loss of life to the Landing Force. He considered the time was now right to make a statement putting the operation as a whole, and the losses incurred, in perspective before the next phase of land operations began.
- 8. Summing up a short discussion, SIR TERENCE LEWIN said they would wish HMS COVENTRY to be named as soon as possible as the ship which had sunk the previous day. They would also wish to invite the News Release Group urgently to prepare an in-depth briefing for accredited defence correspondents on the overall success of the naval operations to date. Finally he instructed the Deputy Chief of the Defence Staff (Intelligence) to prepare as soon as possible an unclassified list of Argentine losses, both of men and equipment, for the News Release Group to issue at an appropriate moment.
