1. PLEASE PASS FOLLOWING MESSAGE FROM THE PRIME MINISTER TO SIR ROBERT MULDOON:

BEGINS

DEAR PRIME MINISTER,

I UNDERSTAND THAT YOU AND YOUR COLLEAGUES WILL VERY SHORTLY DECIDE WHETHER AIR NEW ZEALAND SHOULD BUY THREE BOEING 767'S OR THREE AIRBUS A310'S: AND THAT THE TECHNICAL, OPERATIONAL AND FINANCIAL ARGUMENTS ARE CLOSELY BALANCED.

THERE IS ANOTHER DIMENSION TO THIS DECISION WHICH GREATLY CONCERNS MICHAEL JOPLING AND MYSELF. WE ARE AS YOU KNOW MOST ANXIOUS TO SECURE FINAL AGREEMENT WITHIN THE EUROPEAN COMMUNITY ON THE ARRANGEMENTS FOR CONTINUED ACCESS FOR NEW ZEALAND BUTTER. IT WOULD GREATLY EASE OUR TASK IF YOUR DECISION WERE TO GO IN FAVOUR OF AIRBUS INDUSTRIE SINCE THIS WOULD GIVE A VERY CLEAR SIGNAL THAT NEW ZEALAND DOES WISH, WHEN POSSIBLE, TO PROMOTE THE TRADING INTERESTS OF HER FRIENDS IN THE COMMUNITY.

I AM SURE THAT THIS CONSIDERATION WILL ALREADY HAVE OCCURRED TO YOU. BUT I WANTED YOU TO KNOW THAT IT IS ALSO VERY MUCH IN OUR MINDS AS WE NEGOTIATE TO DEFEND NEW ZEALAND'S INTERESTS IN EUROPE.

Message from Prime Minister to Rt Hon Sir Robert Muldoon ging, CH, MP.

I understand that you and your colleagues will very shortly decide whether Air New Zealand should buy three Boeing 767s or three Airbus A310s: and that the technical, operational and financial arguments are closely balanced.

There is another dimension to this decision which greatly concerns Michael Jopling and myself. We are as you know most anxious to secure final agreement within the European Community on the arrangements for continued access for New Zealand butter. It would greatly ease our task if your decision were to go in favour of Airbus Industrie since this would give a very clear signal that New Zealand does wish, when possible, to promote the trading interests of her friends in the Community.

I am sure that this consideration will already have occurred to you. But I wanted you to know that it is also very much in our minds as we negotiate to defend New Zealand's interests in Europe.
