Introductory Call on the Prime Minister by the New
Zealand High Commissioner on Friday 22 February at 3 pm

I attach a brief for the introductory call by the New Zealand High Commissioner on the Prime Minister, together with a personality note on Mr Walding.

The brief contains rather more substance than normal for an introductory call, in view of the current controversy arising out of the New Zealand Government's decision to reject a US request for a warship visit, and of the call by Mr Lange on the Prime Minister on 4 March. No report has yet reached us of any discussion there may have been in Washington during the visit of the Prime Minister, Foreign Secretary and Defence Secretary. We will see that any report that reaches us of the Foreign Secretary's talks is passed to you without delay.

In addition to the points in the brief about the row over ship visits, the Prime Minister will wish to refer to our very close links with New Zealand and the affection in which both country and people are held in this country.

INTRODUCTORY CALL ON THE PRIME MINISTER BY THE NEW ZEALAND HIGH COMMISSIONER: 22 FEBRUARY 1985

## Our Objective

1. To ensure that he is in no doubt about UK view of present NZ policies and the damage they are doing.

## Arguments to Use

- 2. Western nations face a common threat the USSR. Nuclear deterrence has ensured peace for 40 years. Members of Western alliances must pull together cannot pick and choose benefits. See ANZUS in this light. Shall make this quite clear to Mr Lange.
- 3. NZ policy will only encourage Soviet wedge-driving.
- 4. We share US concern. Ban could rule out RN visits to New Zealand, damage other defence links. Want to find solution to present impasse.
- 5. Mr Lange at liberty to develop his views in Oxford debate. Event may only harden positions.
- 6. If New Zealand is seen to be moving away from the Western camp, its position in the EC will become more difficult.

# Political Arguments

- 7. Western deterrent does not stop at NATO boundaries: development of Soviet Pacific Fleet evidence of need for world-wide vigilance.
- 8. Reduced defence co-operation of any kind only damages West's preparedness.

10. To assure HMG that present NZ policy is not anti-Western.

### Your Response

11. Facts speak for themselves. Soviet message of support demonstrates wedge-driving only too well.

### Press Line

Introductory call. UK concern about dispute within Anzus and hope for quick resolution of problems made clear.

## Background

- 13. Mr Walding has advanced his arrival to be in London for Mr Lange's visit.
- 14. Mr Lange is due to speak at the Oxford Union on 1 March, the motion being that "This House believes that nuclear weapons are morally indefensible". The High Commissioner in Wellington has already pointed out to him the pitfalls of entering the domestic debate.
- New Zealand rejected a US request for a warship visit in March. UK/US policy of "neither confirm nor deny". Americans have reacted by cancelling unilaterally ANZUS and other multinational exercises, including one involving the UK. They are considering a reduction in intelligence exchanges. They have denied moves to impose economic sanctions.

16. Community five-year agreement on New Zealand butter signed July 1984. Quantities for the final two years to be determined

later. Problem is now, not butter access, but butter surplus disposal. UK share of New Zealand trade only 9% but exports up 25% in 1983.

He then went into the catering business and, an entrepreneur by instinct, built up the family firm. In 1959 he became member of Palmerston North City Council and then Labour MP for that constituency, 1967-1975 and 1978-1981. From 1973-5 he was Minister of Overseas Trade, Minister of Recreation and Sport and Associate Minister of Foreign Affairs. Having officially retired from politics in 1982, he acted as Mr Lange's right-hand man during his 1984 election campaign and enjoys his personal confidence. A practising Catholic, he is not a political ideologue. Acute, honest and down-to-earth, he is well disposed towards Britain. Married, with 6 daughters. South Pacific Department February 1985


