#### VISIT BY PRIME MINISTER MULRONEY





CALL ON THE PRIME MINISTER BY THE PRIME MINISTER OF CANADA:

ADVANCE PRESS LINE ON THE RECORD [TO BE CLEARED WITH CANADIANS BEFORE USE]

Talks reflected the wide range of shared goals and interests.

The two Prime Ministers reaffirmed the commitment of their countries to the North Atlantic Alliance, which remains the foundation of their security. They also underlined their commitment to the Commonwealth.

They discussed issues likely to arise at the Bonn Economic Summit, including their approach to a new round of multilateral trade negotiations.

They discussed arms control issues, including a review of positions at the end of the first round of Geneva negotiations. They were in complete agreement on Alliance and arms control objectives, and in supporting US efforts to achieve the agreed aims of the Geneva talks. They agreed that Russians should produce constructive proposals at the negotiating table. Both acknowledged an urgent need for a total chemical weapons ban. [If necessary: There was some discussion of Allied participation in SDI research, which both sides are still considering.]

There was a useful exchange of views on general East/West issues in the light of recent contacts with Soviet Union and East European countries.

Prime Ministers reaffirmed the importance of trade and investment between UK and Canada. They expressed the hope that British and Canadian businessmen would take advantage of the current favourable climate for investment in each other's countries.

They noted with satisfaction the close working contacts between the two Governments and agreed that these should be maintained and strengthened. Other subjects touched on: Central America and Caribbean and the Ottawa CSCE meeting.

#### Defensive

#### SEALS

Ministers are still considering the future of the EC ban on the import of sealskins and products. [If necessary: The Prime Minister noted that the Canadian Royal Commission would be reporting on seals.]

#### PENSIONS

Prime Minister regretted that funds were not available at present to permit unfreezing of UK pensions payable to residents in Canada.
