2. THE SECRETARY OF STATE STRONGLY AGREES WITH SIR A PARSONS (UKMIS NEW YORK TELNO 347) THAT WE SHOULD LOOK VERY FOOLISH IN THE SECURITY COUNCIL TO NO GOOD PURPOSE UNLESS WE COULD PRODUCE ABSOLUTELY CONVINCING EVIDENCE IN PUBLIC OF A GENUINE AND IMMEDIATE INVASION THREAT.
