THE FOREIGN MINISTER SUPMONEH HE THIS EVENING. OR ARIAS BESAY BY SAYING THAT HE MUCH HOPED HE WINLD HAVE GOOD NEWS SHOPTLY. HE SAID THAT AFTER THE CONVERSATION REPORTED IN MY TUR HE HAD SPOKEN TO FRES IDENT BELAUNDE WHO HAD PECIDED TO MAKE A FURTHER ATTEMPT TO BREAK THE DEALCOK AND BRING ABOUT AN INTEDIATE CEASEFIRE. DR ARIAS SAID THAT ON PRESIDENTIAL INSTRUCTIONS HE HAD TELEPHONED COSTA MENDEZ TO PRESS UPON HIM A FORMULA WHICH MIGHT OFFEP THE BEST CHANCE OF AN INNEDIATE SOLUTION. OR ARIAS REPEATED THAT A WAY HAD TO BE FOUND TO ALLOW THE ARGENT THES TO CLIMB DOWN WITHOUT TOO MUCH LOSS OF FACE. THEY HAD THEREFORE CONSIDERED WHETHER A TEXT WHICH WOULD INCLUDE A TOKEN REFERENCE TO THE ARGENTINE CLAIM TO SOVERE IGHTY IN THE (FOLLOWING WORD UNDERLINED) INTRODUCTORY PART MIGHT SUFFICE TO SRING ABOUT A WITHDRAWAL OF THE ARGENTINE TROOPS. PRESIDENT BELAUNDE HAD ALSO TELEPHONED PRESED REAGAN (BUT HAD FAILED TO GET THROUGH) IN ORDER TO INSTILL A SENSE OF URGEYCY AND TO TAKE ADVANTAGE OF THE PRESENCE OF MR PYM IN WASH-INGTON. PR HAIG HAD SUBSEQUENT Y SPOKEN ON THE TELEPHONE SEVERAL TIMES WITH PRESIDENT BELAUNDE. 中央の大学の

DR ARIAS SAID THAT SOME PROCEDURAL DIFFICULTIES HAD ARISEN DURING THE COURSE OF THE VARIOUS TELEPHONE CONVERSATIONS WHICH RELATED TO THE TUCLUSION OF THE UTITED STATES AND/OR PERU AS PEMBERS OF THE TYTERIM ADMINISTRATION. OR ARIAS TOLD ME TY CONFIDENCE THAT PRESIDENT DELAUND! HAD NO OBJECTION TO PERU BEING EXCLUDED IF BY SO DOING A PEACEFUL SETTLEMENT COULD BE CHTAINED. BUT MR HAIG HAD TYTIMATED THAT THE US WOULD NOT WISH TO BE EXCLUDED FROM THE UDMINISTERING GROUP SINC! THIS WOULD OTHERWISE NOT BE ACCEPTABLE TO THE UX.
- 3. IN THE EVENT AND IN ORDER TO SIRPLIFY MATTERS, A 7-POINT FORMULA HAD BEEN WORKED OUT. TEXT IS IN NIFT. THEPE IS A SPANISH TEXT AND AN ENGLISH TEXT THICH DR ARIAS SAID HAD VIRTUALLY BEEN DICTATED OVER THE TELEPHONE MY HAIG.
- 4. IN REPLY TO MY SPECIFIC QUESTION DR ARIAS SAID THAT THE 7-POINT FORMULA HAD THE APPROVAL UF COSTA MENDEZ SEMICOLON THAT GERERAL GALTIER I HAD TOLD PRESIDENT BELAUNDE THAT HE YAS QUETE WELL DISPOSED UNQUOTE TOWARDS IT BUT THAT HE HAD HIS QUOTE SENATE UNQUOTE ( IE THE MIL ITARY JUNTA) TO CONSULT AND CONVINCE. DR ARIAS SAID THAT THE MILITARY JUNTA WAS HEETING EVEN AT THIS MOMENT TO CONSIDER THE TERMS AND THAT A REPLY WAS EXPECTED HOURLY. DR ARIAS SAID THAT HE HAD REASON TO HELIEVE THAT MR HAIG'S PROPUALS HAD BEEN CONVEYED WITH THE KHOWLEDGE OF AT LEASE THE CONSENT OF MR PYM. DR ANIAS EXPHASISED THAT PRESIDENT BELAUNDE WAS ANXIOUS NOT TO LOSE THE NOMENTUM ANDTHAT IT HAD BEEN CONVEYED TO MASHINGTON THAT IF THE FORMULA MAS ACCEPTABLE. THE SIGNATURE OF AN INTERIM DOCUMENT FOULD TAKE PLACE IN LIMA. DR ARIAS WAR VED ME TO EXPECT INSTRUCTIONS TONIGHT AND ADDED THAT THEY WERE MAKING ARRANGEMENTS TO STAGE A GRAND SIGNATURE CEREMONY 14 LIKA.
