NOTE FOR THE RECORD

POSSIBLE VISIT BY MR PAPANICOLAOU, DIRECTOR OF THE ECONOMIC
CABINET OF THE GREEK PRIME MINISTER

When the heads of government in the European Council were meeting at the Greek Prime Minister's house on 5 December and I was lurking helpfully in an antechamber, M. Yiannis Papanicolaou told me that he would shortly be visiting Paris and Bonn in order to inform himself about the organisation of economic business at Cabinet level in France and Germany. He hoped that it would also be possible for him at some time in the first quarter of 1984 to visit London. I expressed interest but made no commitment. If he wishes to follow this up, we shall no doubt hear through the Greek Embassy here.

If he does come, I would suggest that he might speak to Mr Gregson and myself in the Cabinet Office, possibly to Mr N Owen at 10 Downing Street and at an appropriate level in the Treasury and Foreign and Commonwealth Office.


