MY TELNO 3710 (NOT TO ALL): PRIME HINISTER'S MEETING WITH THE PRESIDENT, 22 DECEMBER: MORTHERN IRELAND

 CONGRESSMAN BIAGGI IS SEEKING SIGNATURES FROM COLLEAGUES TO A DRAFT LETTER PRESSING THE PRESIDENT TO INCLUDE NORTHERN IRELAND IN THE AGENDA FOR HIS MEETING WITH THE PRIME MINISTER OF 22 DECEMBER.

2. THE LETTER REFERS TO THE DUSTE LENGTH VANDICESSFUL MEETING QUOOTE SETVED THE PRIVE MILITERS AND BE FIRESHED AND PREFERS TO THE PRIME MILITERS QUOTE REFURSH UNDUSTE TO CONSIDER ANY OF THE FORM RECOMMENDATIONS. 6. THIS IS NOT THE FIRST TIME THAT SHAGS HAS UNGED THE PRESIDENT TO RAISE NORTHERN IRELAND AT MEETINGS WITH THE PRIME MINISTER. HE DID SO BEFORE WILLIAMSDIRG IN 1993.
