APPEAL from Mark NEPOMNIASHCHY which reached us 4.12.84 dictated by Mark to friends the day before his arrest. I ask the people and the Government of Israel and all people of goodwill, to help Jacob Levin and many of us who signed the letter for repatriation to Israel. We consider ourselves the citizens of Israel and we think that the Israeli Government has to send a lawyer to the trial of Jacob Levin, especially as it is not a trial but a reprisal. We think that International lawyers organisations must send their representatives too because our appeal for repatriation was not addressed only to Israel. I ask for help not only for Jacob Levin but for all the Prisoners of Zion, for all the Jews of the USSR. Save us! Help us to depart from here! Help those of us who stay here to be able to study our culture, our language, our history! I ask all the Jews in the world to make a special day for the Defence of Soviet Jewry. Let everyone help us according to his or her ability and ways; with prayers; with fasting and with demonstrations. I ask you to help me too. If legal actions are taken against me I will ask for the same help which I asked for Jacov Levin because I signed the same letter for repatriation and because I am a citizen of Israel too. I would like you to demand the presence of an Israeli lawyer and the representatives from international lawyers organisations. I would like you to demand the revision of the cases of all Prisoners of Zion, because they were imprisoned only because they either wished to leave the USSR or to study Hebrew, Jewish culture, Jewish history and traditions to know and to pass the knowledge to others. This was their real guilt, though they were imprisoned under various pretexts. Our hands are tied. We cannot do anything; we cannot publish anything in newspapers; we have no approach to broadcasting; we cannot demonstrate; we cannot even demand answers to our letters, so we ask you to demand from the Soviet Government answers to our appeals such as the letter for repatriation, or the denial of the statement of Anti-Zionist Committee that no Jews wish to leave the USSR. We have endangered ourselves signing these letters. Everyone of us can be arrested tomorrow on some false pretext, as was in the case of Jacov Levin who, during three years was persecuted by the KGB because of his strictly Jewish activities and now suddenly is charged with Anti-Soviet activities. It is just because there is no paragraph in Soviet laws charging a person with the desire to be a Jew, to study and to teach how to be a Jew. I appeal to former Prisoners of Zion, to the relatives of those who are locked up here, to all who were lucky to depart from here. I ask you to explain to the world that people are sentenced here just because their desire to be Jews. Lask you to stop this shameful reprisal. I ask for help. It is already five years that my family tries to be repatriated to Israel. We have suffered a lot because of the actions of the KGB. Our home was searched on three separate occasions. We were taken for interrogation more than once. We were commanded to stop the teaching of Hebrew, the observance of our holidays and Shabbath. The Chief of the Jewish Department of the Odessa KGB, Col. Krasnov, promised me to introduce me to Shcharansky, i.e. to imprison me the same place. There were a lot of harsh threats from the KGB. For example, when they knew that Jacov Levin was going to marry my daughter, they told him: "He will not marry her. We shall put him in a cell with homosexuals, and we shall put her in a cell with criminals who will rape her before your eyes. Can I be prudent in such a situation? Can I lie low when my daughter is deprived of the right to marry the man she lowes? Have I to wait for my kin to become extinct? Perhaps this appeal is our only defence.
