MY TELNO 539: EXPULSIONS

- 1. M HAVE MANFORMED ALL MEMBERS OF MY STAFF NOW AND MOSCOW AND NAMED AND THE SOVAET COMMUNICATION. ARRANGEMENTS WILL BE PUT AN HAND FOR THE DEPARTURE OF THE THREE REQUIRED TO LEAVE WATHAN FOURTEEN DAYS. A HAVE CAUTHONED THOSE AGAINST WHOM ALLEGATIONS ONLY HAVE BEEN MADE TO KEEP THE AMFORMATION TO THEMSELVES. OF THE FOUR AN THIS CATEGORY LT COR HARDLE AS DUE TO RETURN TO MOSCOW FROM WARSAW LATER TODAY. SON LDR STACEY AS ON LEAVE AN THE UK AND WHEN THE MOD ADVISE HIM HE SHOULD BE SHALLARLY CAUTIONED. AN ADVISE THAT NOTHING REPEAT NOTHING SHOULD BE SAID IN PUBLIC ABOUT THE NAMENC OF THESE FOUR MEMBERS OF MY STAFF.
- THE RUSSIANS HAVE CHOSEN TO ESCALATE OF THE FORST ROUND AND TO CONFINE THEIR RETALIATION TO EMBASSY STAFF SEMIL COLON ALSO TO GIVE US A LITTLE MORE TIME. THE REFERENCE ON THEM PROTEST TO THE THREE OTHER ASSISTANT SERVICE ATTACHES AND EDGAR OF CLEARLY INTENDED AS A THREAT OF FURTHER RETALIATION OF WE PROCEED, AS WE HAVE STATED, TO THE EXPULSION OF ZARKIN, CHERKASOY AND BELAVENTSEV. OF AM NATURALLY CONCERNED THAT WE SHOULD MINIMARIZE THE EXTENT OF FURTHER RETALIATION AND TO AVOID A SUCCESSION OF TOTAL FOR-TAT ACTIONS ON WHICH, AS HAS ALWAYS BEEN RECOGNISED, THE SOVIET AUTHORITIES HAVE THE ULTIMATE ADVANTAGE GIVEN THE NATURE OF THEM SOCIETY. WE MUST CLEARLY PROCEED TO TAKE THE ACTION AGAINST ZAUKUN, CHERKASOY AND BELAVENTSEV ANTICHPATED BY THOMAS (FCO TELNO 384). IF WOULD BE GRATEFUL FOR AS MUCH NOTICE AS POSSIBLE OF THE FURTHER STATEMENT TO THE SOVIET EMBASSY OF LONDON.
- THAT THE RUSS HANS WILL LET HT GO AT THAT. THE POSSHBILLITY MIGHT BE INCREASED IF WE DO NOT GIVE IMMEDIATE PUBLICATY TO THE EXPULSION OF THE THREE. BUT IF THINK IT MUCH MORE LIKELY THAT THEY WILL GO FOR A SECOND ROUND AND PACK AT LEAST TWO OF THE FURTHER FOUR NAMED IN THE PROTEST NOTE, LEAVING HT AT FAVE-ALL EXPELLED ON BOTH SIDES. BUT GIVEN THE THREE FORMER MEMBERS OF THE SOVIET EMBASSY NAMED BY US, IF CERTAINLY DO NOT EXCLUDE THE EXPULSION OF THREE OR EVEN FOUR OF THOSE NOW PUT ON WARNING.

THE CEHLING

THE SOVIETS INTEND TO AMPOSE A CEALING ON THE EMBASSY AN MOSCOW.

BUT THIS IS NOT TO SAY THAT THEY WILL NOT DO SO THEY MAY KEEP THIS UNTIL THE NEXT ROUND AND POSSIBLY UNTIL WE APPLY FOR VISAS FOR REPLACEMENTS.

PRESS LANE

HERE WILL NO DOUBT CONTINUE TO ASK WHETHER IN HAVE BEEN SUMMONED FOLLOWING THE ACTION ANNOUNCED IN LONDON ON 18 APRIL AND TO WHAT EFFECT. UNTIL FURTHER IN TRUCTED, IN PROPOSE TO SAY THAT IN HAVE BEEN SUMMONED BUT THAT THE NATURE OF MY COMMUNICATION WITH THE SOVIET MINISTRY OF FOREIGN AFFAIRS REMAINS FOR THE MOMENT CONFIDENTIFAL. SUSLOV DID NOT SAY WHETHER THE SOVIET SIDE WOULD BE GIVING PUBLICATY TO THE COUNTER EXPULSIONS AND ENTENTIONALLY IN DIED NOT ENQUIRE. IN THINK IT WOULD BE ADVISABLE FOR US TO GO PUBLIC FORST ON THE EXPULSION OF THE THREE MEMBERS OF MY STAFF. GRATEFUL FOR EARLY INSTRUCTIONS.
