GREEK CYPRIOT GENERAL ELECTIONS

THE COUNTING OF VOTES HAS BEEN SLOWER THAN EXPECTED AND THE FULL RESULTS AND FINAL ALLOCATIONS OF SEATS IN THE NEW HOUSE OF REPRESENTATIVES WILL NOT BE ANNOUNCED UNTIL LATER TONIGHT OR TOMORROW. BUT WITH APPROXIMATELY THREE QUARTERS OF THE VOTES COUNTED, THE RESULTS SHOW THAT:-

A. KYPRIANOU'S PARTY (DEKO) WILL BE SIGNIFICANTLY STRENGTHENED:

- B. THE COMMUNISTS (AKEL) WILL LOSE SUBSTANTIALLY AND CEDE THIER PLACE AS THE BIGGEST SINGLE PARTY:
- C. THE OPPOSITION (DEMOCRATIC RALLY AND AKEL) ARE LIKELY TO FAIL
 IN THEIR ATTEMPT TO SECURE TWO THIRDS OF THE SEATS IN THE NEW
 HOUSE AND THUS TO BE FRUSTRATED IN THEIR DECLARED AIM OF FORCING
 KYPRIANOU TO RESIGN BY AMENDING THE CONSTITUTION.

THIS REPRESENTS A GREATER INCREASE IN SUPPORT FOR DEKO THAN EXPECTED EVEN AFTER ALLOWING FOR THE LION'S SHARE THEY WERE EXPECTED TO TAKE OF THE VOTES CAST FOR MINOR PARTIES WHICH STOOD IN 1981 BUT NOT IN 1985. THE QUESTION OF IMMEDIATE INTEREST IS WHETHER AKEL OR DEKO WILL EMERGE AS THE SECOND STRONGEST PAJTY.
