

YOUR TELNO 114: CYPRUS

- 1. BEFORE RECEIPT OF YOUR TUR I SAW THE SECRETARY GENERAL ON THE EVENING OF 24 FEBRUARY AND BRIEFED HIM IN ACCORDANCE WITH PARAS 5 TO 8 OF YOUR TELNO 62 TO ANKARA. HE WAS MOST GRATEFUL FOR THE PRIME MINISTER'S FORTHRIGHT STRESS ON THE POINTS WHICH HE HAD SUGGESTED MIGHT BE USEFULLY MADE TO MR OZAL.
- 2. PEREZ DE CUELLAR TOOK NOTE AND DID NOT SEEM SURPRISED AT THE LINE OZAL HAD FOLLOWED. AS OZAL HAD DONE, HE RECURRED TO KYPRIANOU'S FAILURE TO ACCEPT THE 17 JANUARY PROPOSALS AS AN IMPORTANT MISSED OPPORTUNITY. HE WAS INCLINED TO THINK THAT KYPRIANOU HAD SINCE MOVED FURTHER AWAY FROM ACCEPTANCE. HE WAS CONCERNED AT THE MALIGN INFLUENCE WHICH PAPANDREOU MIGHT BE EXERCISING. HE HOPED THAT YOU WOULD BE ABLE TO COUNTERACT THIS DURING YOUR FORTHCOMING VISIT TO ATHENS. BUT HE WAS NOT OPTIMISTIC. HE THOUGHT KYPRIANOU WAS NOT ACTING IN GOOD FAITH.
- 3. PEREZ DE CUELLAR TOLD ME THAT AT THE FORTHCOMING WORKING LEVEL MEETING IN GENEVA HIS TEAM WOULD GO OVER THE 8 OUTSTANDING POINTS WITH BOTH SIDES IN ORDER TO MAKE AND TO GAIN ELUCIDATIONS. THEY WOULD NOT PUT FORWARD ANYTHING IN WRITING. WHEN THEY RETURNED TO NEW YORK THEY WOULD USE THIS EXPERIENCE TO AMEND AS APPROPRIATE THE PAPER WHICH

IN WRITING. WHEN THEY RETURNED TO NEW YORK THEY WOULD USE THIS EXPERIENCE TO AMEND AS APPROPRIATE THE PAPER WHICH HE WAS PREPARING TO GIVE TO BOTH SIDES. THAT WOULD BE THE NEXT STEP. IN OTHER WORDS HE WAS NOT, REPEAT NOT, CONTEMPLATING A FURTHER WORKING LEVEL MEETING AFTER GENEVA. HE WOULD PROBABLY PUT HIS PAPER FORWARD TO BOTH SIDES SIMULTANEOUSLY IN APRIL. HE WAS CONTEMPLATING THE POSSIBILITY OF DOING IT HIMSELF. FOR THIS PURPOSE HE MIGHT INVITE KYPRIANOU AND DENKTASH TO JOIN HIM AT SOME CONVENIENT PLACE. I GUESS HE MAY HAVE GENEVA IN MIND. HOWEVER, IT WAS FAR FROM CERTAIN THAT THIS COULD BE FITTED INTO HIS TIMETABLE. IF NOT, HE WOULD PROBABLY AS MR GOULDING TO TAKE IT TO CYPRUS AND PRESENT IT PERSONALLY TO THE TWO LEADERS IN ORDER TO UNDERLINE ITS FORMALITY AND DISTINGUISH IT FROM YET ANOTHER WORKING PAPER.

4. I WILL TAKE AN OPPORTUNITY TO ASSURE THE SECRETARY GENERAL THAT YOU ARE READY TO SPEAK TO THE GREEKS IN SIMILARLY DIRECT TERMS WHEN YOU VISIT ATHENS NEXT MONTH. I WILL ALSO PASS ON THE OTHER COMMENTS IN YOUR TUR TO THE EXTENT THAT I HAVE NOT ALREADY DONE SO.
