1. THE ONLY POINTER TO TURKISH ATTITUDES WHICH IN CAN ADD TO THOSE SET OUT IN MY TELNO 200 IN A CONVERSATION WITH MESUT VILMAZ WHICH IN HAD AT A SOCIAL FUNCTION ON 11 APRIL. YILMAZ IS A MINISTER OF STATE, WHO ACTS AS FOREIGN MINISTER IN MR HALEFOGLU'S ABSENCES ABROAD. HE IS CLOSE TO DZAL. IN ANSWER TO MY QUESTION HE SAID THAT DENKTASH WOULD AGREE TO THE NEW DOCUMENTATION. WHEN IN COMMENTED THAT DENKTASH SEEMED INCLINED TO WANT TO SEE HOW THE GREEKS JUMPED, AND TO PUT DOWN SOME QUALIFICATIONS OF HIS OWN, YILMAZ SAID: "HE WILL AGREE.

2. THAT REMARK GOES A GOOD DEAL FURTHER THAN LOGOGLU (MY TELNO 200) BUT COMES FROM A CONSEDERABLY MORE SENSOR SOURCE. ALTOGETHER THANK THE EMPLICATIONS ARE THAT THE TURKS, AS THANGS STAND, ARE ON BOARD AND THAT WHATEVER DENKTASH'S MISGINIANGS, ANKARA (A) AS READY TO AGREE TO THE DOCUMENTATION AN PRESENT FORM AND (B) WILL REQUIRE DENKTASH ALSO TO AGREE. THE QUESTION THEREFORE, AS FAR AS WE ARE CONCERNED HERE, AS WHETHER THE SECRETARY GENERAL'S PROPOSALS AN UKMAS TELNO 357 WOULD RASK LOSING THE TURKS.

- 3. ON THAT HISSUE MY VIEWS ARE AS FOLLOWS:-
- (A) ANKARA AS PROBABLY KEENER ON ACCEPTANCE THAN AS DENKTASH.

 THE LATTER MAY WELL BE LOOKING FOR AN EXCUSE TO DELAY MATTERS AND WOULD NOT BE TOO UNHAPPY TO SEE THE PROCESS BREAK DOWN PROVIDED THE BLAME DAD NOT LIKE WITH HAM.
- (B) HE HS THEREFORE LIKELY TO SENZE ON ANY MOVE AWAY FROM WHAT THE SEC GEN HAS ALREADY PROPOSED, PARTICULARLY HE HT CAN BE SHOWN AS A REVISION TO MEET KYPRIANOU.
- (C) & WOULD NOT PLACE ANY RELMANCE ON FERSSEL'S OPTIMISM THAT
 THERE AS NOTHING AN THE SEC GEN'S NEW POINTS TO WHICH THE
 TURKS SHOULD OBJECT. DENKTASH HAS ON MANY OCCASIONS SHOWN
 HOW ADEPT HE AS AT NIT-PACKING. THOUGH THAS AS A POINT
 FOR MR WILBERFORCE, & DO NOT DOUBT HIS CAPACITY TO FAND
 OBJECTIONS TO THE SORT OF FORMULA THE SEC GEN HAS PROPOSED.

HOW ADEPT HE IS AT WHT-PACKING, THOUGH THAS IS A POINT FOR MR WALBERFORCE, IN DO NOT DOUBT HIS CAPACITY TO FIND OBJECTMONS TO THE SORT OF FORMULA THE SEC GEN HAS PROPOSED. (D) ANKARA, NOT WITHSTANDING (A) ABOVE HS AN NO MOOD TO MAKE LIFE EASIER FOR EATHER KYPRIANOU OR PAPANDREOU. LET HE THE TURKS SENCE THAT KYPRHANOU IS TRYING TO WRIGGLE OFF HOOK THEY WILL, IN FEAR, SEEK TO MAIL HIM. ON THUS THEY WOULD BE AT ONE WATH DENKTASH. 4. GIVEN THE ABOVE CONSIDERATHONS, A THINK THERE IS A REAL RISK IM WHAT THE SEC GEN PROPOSES. BUT WE ARE AT A CRISTICAL POINT IN THE NEGOTIATIONS AND THE PRIME OBJECTIVE IS TO KEEP THE PROCESS GOING. INT AS THEREFORE JUST AS IMPORTANT TO GET KYPRHANOU ON BOARD AS TO SECURE DENKTASH. THE QUESTION 45 CAN WE GET KYPRHANOU (NEXT WORD UNDERLAMED) WATHOUT THE SORT OF MANOUEVRE WHICH THE SEC GEN PROPOSES. THAT IS FOR MR WILBERFORCE AND MR THOMAS TO JUDGE. AF AR AS FELT THAT SUCH A MANOUEVRE COULD HAVE A CRAITICAL EFFECT ON KYPRIANOU THEN & THINK WE PROBABLY SHOULD GIVE THE SEC GEN'S PROPOSAL A TRY SUBJECT TO PARA 5 BELOW. BUT WE MUST RECKON WAITH THE LAKELIHOOD THAT DENKTASH AND ANKARA WALL SEE AT AS A PRO-KYPRIMANOU MOVE AND MAKE DIFFACULTIES, NOT NECESSARILY BY REJECTIONS THE DOCUMENTATION, BUT AM DEMANDS FOR AN UNEQUINOCAL ACCEPTANCE BY KYPRIANOU. 5. WE NEED ALSO TO ADDRESS THE AFFECT THAS WOULD HAVE ON OUR RELATIONS WITH THE TURKS, GIVEN THAT WE MUST EXPECT THEM TO LEARN OF OUR INTERVENTION, POSSIBLY FROM THE GREEKS AND IN A WAY CALCULATED TO EMBARRASS US. ANKARA AND DENKTASH MAY FEEL THAT WE ARE INTERVENING TO GET KYPRIANOU OFF THE HOOK TO THEIR DISADVANTAGE. FOR THIS REASON IN BELIEVE WE SHOULD BE CAREFUL TO ENSURE THAT IN WHATEVER WE SAY TO THE GREEKS WE CONFINE DURSELVES TO REASURANCES BASED ON THE EXILSTING DOCUMENTATION AND AVOID SEEMING TO BROACH NEW, CONTENTAOUS, GROUND. DESPITE FEASSEL'S REMARKS, AT SEEMS TO ME THAT (C) OF THE SEC HEN'S THREE POINTS WOULD GET US MATO THAT POSITION 4.E. AN SUGGESTING THAT THE FIRST HIGH LEVEL MEETING SHOULD BE A SUBSTANTINE ONE RATHER THAN SYMBOLAC. IF , NOTWITHSTANDING, AT WAS DECIDED THAT (C) WAS AN INDISPENSIBLE ELEMENT TO THE APPROACH, THEN IN MUST STRONGLY RECOMMEND THAT WE SHOULD INFORM THE TURKISH GOVERNMENT OF OUR EXCHANGE WATH KYPRHANOU, TO GUARD AGAINST BEING ACCUSED SUBSEQUENTLY BY THE TURKS OF PARTHALATY.
