- 1. I THINK WE CAN DISCOUNT ANY RISK OF THE TURKISH GOVERNMENT DOING ANYTHING SO STUPIDLY PROVOCATIVE AT THIS JUNCTURE AS PERMITTING SOME TURKISH CYPRIOT SETTLEMENT OF VAROSHA. THE ARGUMENTS IN FAVOUR OF SHOWING RESTRAINT AT THE PRESENT TIME SEEM WELL UNDERSTOOD ON THE TURKISH SIDE, AND THE TURKISH AMBASSADOR CONFIRMED TO ME ON 20 JUNE THAT HE HAD BEEN URGING THIS ON DENKTASH.
- 2. ALL THE EVIDENCE HERE IS THAT THE FOCUS OF OZAL'S VISIT WILL

  BE ECONOMIC, WITH THE OBJECT OF LAYING A FIRMER BASIS FOR

  THE DEVELOPMENT OF THE TRNC AND OF CURING THE CONSTANT

  DIFFICULTIES OVER TURKISH BUDGETARY ASSISTANCE WHICH HAVE LONG

  PLAGUED RELATIONS BETWEEN THE TRNC AND ANKARA. I AM VERY SCEPTICAL

  ABOUT THE NOTION OF AN INDEPENDENT TRNC CURRENCY, AND RUMOURS OF

  THIS ARE NOT PARTICULARY PROMINENT AT THE MOMENT. ONE SPECIFIC

  PLAN WHICH THE TURKISH AMBASSADOR MENTIONED TO ME ON 20 JUNE IN

  THE CONTEXT OF OZAL'S VISIT WAS FOR THE ABOLITION OF CUSTOMS DUTIES

  IN THE NORTH AND THE INTRODUCTION INSTEAD OF A FORM OF VAT OR

  SALES TAX. (TUNABAS DID NOT APPEAR TO HAVE CONSIDERED HOW THIS

  WOULD SQUARE WITH THE APPROACH TOWARDS THE NORTH'S INCLUSION IN

  CUSTOMS UNION WITH THE COMMUNITY).
- 3. I HAVE DISCUSSED THE PROSPECTS WITH HOLGER. WE AGREED THAT IT WOULD BE UNPROFITABLE TO TRY TO ADVISE THE TURKISH GOVERMENT AGAINST TAKING THE PRACTICAL MEASURES WHICH THEY JUDGED NECESSARY FOR THE GOOD OF THE TRNC ECONOMY. WE AGREED ALSO, HOWEVER, THAT THE GREEK CYPRIOTS, IN THEIR PRESENT EMBITTERED MOOD, WOULD BE LIABLE TO SEIZE ON ALMOST ANY MEASURES ANNOUNCED DURING OZAL'S VISIT AS A PRETEXT FOR A FRESH WAVE OF INTERNATIONALISATION OF THE CYPRUS PROBLEM, WHICH KYPRIANOU IS RUMOURED TO HAVE BEEN PREPARING WITH PAPANDREOU. THIS COULD INVOLVE NOT ONLY RECOURSE TO THE UN BUT ALSO PERHPAS A FRESH ATTEMPT TO TIGHTEN THE ECONOMIC EMBARGO ON THE NORTH BY UPSETTING THE PRESENT ARRANGEMENTS
