- A. N N SLYUNKOV AND A N YAKOVLEV ARE PROMOTED FROM CANDIDATE
 TO FULL MEMBERSHIP OF THE POLITBURO.
- B. V P NIKONOV (CENTRAL COMMITTEE SECRETARY FOR AGRICULTURE)
 18 MADE A FULL MEMBER OF THE POLITBURO.
- C. D T YAZOV (MINISTER OF DEFENCE) IS PROMOTED FROM CANDIDATE
 TO FULL MEMBER OF THE CENTRAL COMMITTEE AND ELECTED A
 CANDIDATE MEMBER OF THE POLITBURO.
- D. S L SOKOLOV (FORMER MINISTER OF DEFENCE) IS RELEASED AS CANDIDATE MEMBER OF THE POLITBURO IN CONNEXION WITH HIS RETUREMENT.
- E. D A KUNAEV IS EXPELLED FROM THE CENTRAL COMMITTEE FOR SERIOUS SHORTCOMINGS WHEN PARTY LEADER IN KAZAKHSTAN.

2. COMMENT

OF THE THREE NEW POLITBURO MEMBERS TWO, YAKOVLEV AND NIKONOV,
ARE CLOSE TO GORBACHEV AND WILL SIGNIFICANTLY STRENGTHEN IS
POSITION. THE PROMOTION OF HIS RIGHT-HAND MAN FOR IDEOLOGICAL
MATTERS, YAKOVLEV, IS PARTICULARLY IMPORTANT AND SHOULD GIVE A
NEW IMPETUS TO INTERNAL REFORM: IT ALSO PLACES A QUESTION MARK
AGAINST THE STATUS OF LIGACHEV SINCE THEIR RESPONSIBILITIES OVERLAP.

3. SLYUNKOV, AS A SENIOR SECRETARY DEALING WITH ECONOMIC AFFAIRS, WILL HAVE ADDED WEIGHT IN OVERSEEING THE IMPLEMENTATION OF THE ECONOMIC REFORM. IT IS SIGNIFICANT THAT HE IS NOW SENIOR IN PARTY RANK TO THE CHAIRMAN OF GOSPLAN TALYZIN WHO IS REPORTED TO HAVE BEEN RESISTING GORBACHEV'S PLANS FOR RESTRUCTURING THE ECONOMIC ADMINISTRATION.

Restricted 4. NIKONOV'S PROMOTION IS UNEXPECTED SINCE HE HAD NOT APPEARED TO BE PARTICULARLY IMPRESSIVE OR INFLUENTIAL. BUT IT RESTORES THE TRADITION OF POLITBURO MEMBERSHIP FOR A PARTY SECRETARY FOR AGRICULTURE. 5. THE REPLACEMENT OF SOKOLOV AS CANDIDATE MEMBER BY YAZOV WHO RECENTLY SUCCEEDED HIM AS DEFENCE MINISTER IS ROUTINE. 6. DESPITE VERY STRONG RUMOURS OF HIS IMPENDING REMOVAL FOR REASONS OF HEALTH AND/OR CORRUPTION ALIEV REMAINS IN THE POLITBURO. HE HAS NOT MADE A PUBLIC APPEARANCE SINCE 8 MAY. 7. THE MEMBERSHIP OF THE POLITBURO HAS BEEN INCREASED FROM 11 TO 14 AND THE NUMBER OF SECRETARIES WHO ARE FULL MEMBERS OF THE POLITBURO HAS BEEN DOUBLED FROM 3 TO 6. MY TELS NOS 911-914 AND 916-917: CENTRAL COMMITTEE PLENUM: COMMENT

- 1. THIS APPEARS TO HAVE BEEN A GOOD PLENUM FOR GORBACHEV AND BETTER THAN WE HAD ANTICIPATED IN VIEW OF SIGNS THAT HE WAS ENCOUNTERING STIFF RESISTANCE IN THE RUN-UP TO IT (SEE MY TELNO 861 ON THE CENTRAL COMMITTEE ECONOMIC CONFERENCE).
- 2. IN THE EVENT, THE CENTRAL COMMITTEE HAS ENDORSED THE MAIN PRINCIPLES OF HIS QUICK RADICAL PROPOSALS FOR ECONOMIC REFORM, ALTHOUGH THE TIMETABLE HAS SLIPPED AND THERE IS LIKELY TO BE CONSIDERABLE FOOT-DRAGGING AHEAD, PARTICULARLY OVER THE TRANSLATION INTO PRACTICE OF HIS PLANS TO REDUCE THE POWERS OF THE CENTRAL ECONOMIC AGENCIES AND FOR PRICE REFORM AND THE INTRODUCTION OF WHOLESALE TRADE IN PRODUCER GOODS.
- 3. MOST IMPORTANTLY, GORBACHEV SEEMS TO HAVE ACHIEVED A BREAKTHROUGH IN CHANGING THE COMPLEXION OF THE POLITBURO. THE ELECTION OF 3 NEW FULL MEMBERS MEANS THAT 8 OF THE 14 HAVE BEEN APPOINTED SINCE HE TOOK POWER AND THE OLD GUARD IS NOW OUTNUMBERED AND VULNERABLE. MOREOVER, THE DOUBLING OF THE NUMBER OF SENIOR PARTY SECRETARIES HAS CONSIDERABLY DILUTED THE AUTHORITY OF HIS MAIN POTENTIAL RIVAL, LIGACHEV, WHO COULD PERHAPS BE MOVED ASIDE OR KICKED UPSTAIRS TO REPLACE GROMYKO AS PRESIDENT.

4. ALL IN ALL, THIS JUNE PLENUM HAS LEFT GORBACHEV IN A STRONGER POSITION TO CARRY THROUGH POLICIES OF REFORM WHICH ARE NOW ACCEPTED AND EDNORSED BY THE PARTY ESTABLISHMENT MORE UNEQUIVOCALLY THAN BEFORE.

MIPT: CENTRAL COMMITTEE PLENUM ON ECONOMIC REFORM: GORBACHEV'S REPORT: ECONOMIC REFORM

- 1. THE FOLLOWING ARE THE MAIN POINTS ON THE ECONOMY AND REFORM PROPOSALS:
- (1) GORBACHEV BLAMED MISCALCULATIONS BY GOSPLAN AND GOSSNAB FOR THE POOR ECONOMIC PERFORMANCE AT THE BEGINNING OF THIS YEAR, AS A RESULT OF WHICH CONSIDERABLE LOSSES HAD BEEN SUSTAINED.
- (II) THE PLENUM WOULD APPROVE A DOCUMENT ON 'BASIC GUIDELINES FOR THE RADICAL RESTRUCTURING OF ECONOMIC MANAGEMENT'. BY THE END OF THE YEAR A WHOLE 'PACKAGE' OF SPECIFIC DECISIONS ON REORGANISATION WOULD BE ADOPTED AS WELL AS NEW DIRECTIVES ON THE CENTRAL PLANNING ORGANS AND INDUSTRIAL MINISTRIES IN ORDER TO BRING THE METHODS OF CENTRAL PLANNING INTO LINE WITH THE NEW LAW ON THE SOCIALIST ENTERPRISE.
- (111) THERE WOULD BE A TRANSITIONAL PERIOD IN THE NEXT FEW YEARS DURING WHICH NEW AND OLD MANAGEMENT METHODS WOULD HAVE TO COEXIST. THE TRANSFER OF ENTERPRISES TO SELF-FINANCING WOULD OCCUR BEFORE THE INTRODUCTION OF NEW PRICES AND THE REFORM OF THE SUPPLY SYSTEM AND FINANCIAL SYSTEM. THIS WOULD GIVE RISE TO DIFFICULTIES AND CONTRADICTIONS.
- (IV) GORBACHEV CRITICISED OBSTRUCTIVE ATTITUDES TO PRIVATE PLOTS AND CALLED FOR THE LEASING OF ABANDONED SMALL HOLDINGS TO CITY DWELLERS ON THE BASIS OF CONTRACTS FOR THE OUTPUT OF AGRICULTURAL PRODUCTS.
- (V) HE CALLED FOR THE EXTENSION OF THE FAMILY CONTRACT SYSTEM AND SAID THAT FOR TOO LONG THEY HAD TRIED TO MANAGE THE ECONOMY ON THE BASIS OF ENTHUSIASM OR BY DECREES FORGETTING PERSONAL INTEREST AND INCENTIVES. GORBACHEV DENIED THAT FAMILY CONTRACTS IN AGRICULTURE CONTRADICTED THE PRINCIPLES OF SOCIALISM OR CORRUPTED WORKERS. IT WAS THE PRACTICE OF SUBSIDISING NEGLIGENCE FROM THE BUDGET WHICH CORRUPTED FARM WORKERS.

(VI) GORBACHEV AGAIN RAISED THE STAGNATION OF THE SOVIET ECONOMY
IN THE 1970S AND EARLY 1980S WHEN 'ONE POSITION AFTER ANOTHER
HAD BEEN CONCEDED' AND THE GAP IN EFFICIENCY, QUALITY AND
TECHNOLOGICAL DEVELOPMENT WITH MOST DEVELOPED COUNTRIES HAD
WIDENED. HE REFERRED TO THE 'UNHEALTHY CHARACTER' OF THE
DEVELOPMENT OF THE ECONOMY, THE NEGLECTED STATE OF MACHINE
BUILDING AND EXHORBITANT OUTLAYS FOR BUILDING UP THE FUEL AND
ENERGY BRANCHES. SPENDING ON WAGES HAD SYSTEMATICALLY EXCEEDED
PLAN FIGURES WHICH MEANT THAT MONEY HAD BEEN PAID OUT WITHOUT ANY
CONNECTION WITH RESULTS. THERE HAD BEEN AND REMAINED A SHORTAGE
OF EVERYTHING: METAL, FUEL, CEMENT, MACHINERY AND CONSUMER GOODS
''IF WE ADD TO THIS A CHRONIC SHORTAGE OF MANPOWER IT BECOMES
CLEAR THAT IN SUCH CONDITIONS THE ECONOMY CANNOT DEVELOP NORMALLY''.

(VII) BUT THE MOST ALARMING THING WAS THE BEGINNING OF A LAG IN SCIENTIFIC AND TECHNICAL DEVELOPMENTS AND THE ECONOMY'S 'UNRESPONSIVENESS TO INNOVATIONS''. THE ECONOMIC SITUATION HAD HAD AN 'EXTREMELY NEGATIVE EFFECT' ON THE LIVING STANDARDS OF THE POPULATION AND ON THE DEVELOPMENT OF THE SOCIAL SPHERE.

(VIII) 'THE POLITBURO CONSIDERS IT NECESSARY TO SAY ALL THIS FRANKLY ONCE AGAIN, NOT LEAST BECAUSE VOICES ARE SOMETIMES HEARD ASKING: IS EVERYTHING SO BAD, IS THERE A NEED TO SHARPEN EVALUATIONS AND IS A RADICAL RESTRUCTURING REALLY NECESSARY''? IF SUCH SENTIMENTS PREVAILED AND CURRENT POLICY REFLECTED SUCH PRONOUNCEMENTS THIS WOULD HAVE BEEN FRAUGHT WITH EXTREMELY SERIOUS CONSEQUENCES FOR THE COUNTRY AND THE PEOPLE.

- (IX) THE CHANGES WHICH HAD BEEN MADE IN THE PAST TWO YEARS HAD NOT BEEN FUNDAMENTAL OR CARDINAL ONES. THE BRAKING MECHANISM HAD NOT YET BEEN OVERCOME AND NOT REPLACED BY A MECHANISM OF ACCELERATION.
- (X) GORBACHEV REFERRED TO EARLIER ATTEMPTS AT ECONOMIC REFORM IN THE 1950S, THE SECOND HALF OF THE 1960S AND IN THE LATE 1970S AND SAID THAT THOSE ATTEMPTS HAD NOT BEEN THROUGH-GOING OR PERSISTENT AND HAD ONLY HAD SHORT-LIVED EFFECTS.
- (XI) GORBACHEV DENIED THAT PERESTROIKA MEANT A DEPARTURE FROM OR A WEAKENING OF THE FOUNDATIONS OF SOCIALISM. WHAT WAS PROPOSED WOULD STRENGTHEN SOCIALISM AND REMOVE WHAT WAS HOLDING BACK ITS PROGRESS.

- OF COOPERATIVE AND INDIVIDUAL ENTERPRISES AND CRITICISED THE
 RESPONSE TO DECISIONS WHICH HAD BEEN TAKEN ABOUT THIS 'OFTEN
 PEOPLE HAVE TALKED NOT ABOUT HOW TO USE THE OPPORTUNITIES MORE
 QUICKLY AND EFFECTIVELY BUT HOW LEGITIMATE THESE FORMS OF ECONOMIC
 ACTIVITY ARE AT THIS STAGE OF SOCIALISM. SOME PEOPLE EVEN SEE
 COOPERATIVE AND INDIVIDUAL LABOUR AS A REVIVAL OF PRIVATE
 ENTERPRISE'.

(XIII) GORBACHEV REFERRED TO THE FAULTS OF THE STATE ECONOMIC MECHANISM WHICH WAS GEARED TO AVERAGE OR EVEN POOR WORK ''HOW CAN THE ECONOMY MAKE PROGRESS IF IT OFFERS HOT HOUSE CONDITIONS FOR LAGGARDS, WHILE HITTING FRONT-RUNNERS ?''.

(XIV) IN FUTURE THE PLAN SHOULD BE BASED NOT ON A MULTITUDE OF DETAILED TARGETS HANDED DOWN BY SUPERIOR AGENCIES BUT ON DIRECT COMMERCIAL ORDERS PLACED BY STATE ORGANISATIONS, ENTERPRISES OPERATING ON A SELF-FINANCING BASIS ETC'. THERE SHOULD BE ENCOURAGEMENT FOR ECONOMIC COMPETITION AMONG FACTORIES TO MEET CONSUMER DEMAND. IF AN ENTERPRISE FAILED TO PAY ITS WAY QUESTIONS COULD BE RAISED OF REORGANISING IT OR LIQUIDATING IT. THIS WAS OF COURSE AN EXTREME MEASURE AND THE STATE WOULD SHOW CONCERN TO PROVIDE JOBS.

(XV) APPREHENSIONS HAVE BEEN EXPRESSED ABOUT A WEAKENING OF THE PLANNING PRINCIPLE WHICH COULD AFFECT THE BALANCE OF THE ECONOMY. BUT IT WAS AN ILLUSION TO SUPPOSE THAT EVERYTHING COULD BE FORESEEN FROM THE CENTRE WITHIN THE FRAMEWORK OF SUCH A HUGE ECONOMY.

(XVI) CONCERN HAD ALSO BEEN EXPRESSED THAT IF VOLUME TARGETS FOR ENTERPRISES WERE DISCARDED, RATES OF GROWTH IN SOME INDUSTRIES, REGIONS AND EVEN THE COUNTRY AS A WHOLE MIGHT FALL. GORBACHEV COMMENTED THAT HIGHER GROWTH THROUGH INFLATED GROSS OUTPUT AND DOUBLE COUNTING WITHOUT REAL INCREASE OF END RESULTS WAS OF NO VALUE TO SOCIETY AND EVEN CAUSED LOSSES.

(XVII) A RADICAL IMPROVEMENT OF THE PRICING SYSTEM WAS ESSENTIAL FOR A COMPLETE TRANSITION TO THE NEW ECONOMIC MECHANISM. THIS WOULD INVOLVE WHOLESALE AND RETAIL PRICES PROCUREMENT PRICES AND TARIFFS. IN VIEW OF THE POLITICAL AND SOCIAL IMPORTANCE OF THE REFORM, IT SHOULD BE DISCUSSED THROUGHOUT THE COUNTRY. THERE WOULD ALSO BE A REFORM OF THE SYSTEM OF MATERIAL AND TECHNICAL SUPPLY WHICH WOULD INVOLVE A DECISIVE TRANSITION TO WHOLESALE TRADE IN THE MEANS OF PRODUCTION.

(XVIII) GORBACHEV ALSO REFERRED TO THE NEED FOR A RADICAL REFORM OF THE FINANCE AND CREDIT SYSTEM AND STRESSED THE IMPORTANCE OF RECENT DECISIONS IN THE SPHERE OF FOREIGN ECONOMIC POLICY FOR ENHANCING THE IMPACT OF THE EXTERNAL MARKET ON THE PERFORMANCE OF SOVIET INDUSTRIES AND ENTERPRISES, ON QUALITY AND TECHNOLOGICAL PROGRESS.

(XIX) THE TRANSFER OF ENTERPRISES AND ASSOCIATIONS TO COMPLETE SELF-FINANCING SHOULD BE COMBINED WITH THE RIGHT TO LAUNCH-JOINT VENTURES AND AMALGAMATIONS ON THE BASIS OF SHAREHOLDING UP TO AND INCLUDING COMPLETE MERGER IF THIS WAS ECONOMICALLY EXPEDIENT.

(XX) MINISTRIES SHOULD BE RELIEVED OF THE FUNCTIONS OF OPERATIONAL ECONOMIC MANAGEMENT AND STAFF CONCERNED WITH THIS ELIMINATED.

(XXI) GORBACHEV REFERRED TO THE SETTING UP OF 'PRODUCTION MANAGEMENT BOARDS' AT REGIONAL LEVEL TO PLAN REGIONAL DEVELOPMENT AND COORDINATE ALL LOCAL ECONOMIC ACTIVITIES.

(XXIII) HE CALLED FOR MAXIMUM OPENNESS IN DECISIONS ON SOCIAL AND ECONOMIC LIFE, WIDER PUBLICATION OF DRAFTS AND DECREES AND OF ECONOMIC AND SOCIAL STATISTICS.

(XXIV) GORBACHEV DESCRIBED THE MEASURES HE HAD OUTLINED AS THE MOST THOROUGH GOING AND SWEEPING REFORM OF THIS KIND DURING THE PERIOD OF BUILDING SOCIALISM.

- WHICH HAD PERIODICALLY SHOWN UP LACK OF DISCIPLINE AND ORDER SUCH AS THE LANDING OF THE CESSNA IN MOSCOW WHICH HE DESCRIBED AS "AN UNPRECEDENTED OCCURRENCE FROM ALL POINTS OF VIEW". IT HAD DEMONSTRATED THAT THE NEGATIVE TRENDS EXPOSED AT THE PARTY CONGRESS WERE STRONG AND TENACIOUS IN SOCIETY AND EVEN IN THE ARMY. GORBACHEV WENT ON TO DECLARE "ON BEHALF OF THE POLITBURO AND THE DEFENCE COUNCIL THAT THERE SHOULD BE NO DOUBT IN THE PARTY OR AMONG THE PEOPLE ABOUT THE ABILITY OF THE ARMED FORCES OF THE USSR TO DEFEND THE COUNTRY".

(X114) GORBACHEV STATED THAT THE ATMOSPHERE OF OPENNESS WHICH HAD DEVELOPED IN THE COUNTRY SHOULD NOT ONLY BE PRESERVED BUT DEEPENED AND DEVELOPED. SOVIET UNION: DEBATE ON INTERNAL REFORM

SUMMARY

1. LIBERAL SOVIET ECONOMISTS, HISTORIANS AND WRITERS ARE BECOMING INCREASINGLY OUTSPOKEN. IN A NUMBER OF RECENT ARTICLES AND STATEMENTS AT PUBLIC MEETINGS SOME OF THEM HAVE NOT JUST ATTACKED INDIVIDUAL SACRED COWS BUT HAVE BEGUN TO RAISE FUNDAMENTAL QUESTIONS ABOUT THE SYSTEM ITSELF. THE COMMON THREAD IN THESE STATEMENTS IS AN ASSAULT ON THE WHOLE STALIN PERIOD AS A DISTORTION OF LENIN'S IDEAS AND INTENTIONS ABOUT THE ECONOMIC AND POLITICAL SYSTEM.

DETAIL

- 2. THE MOST SIGNIFICANT RECENT STATEMENTS HAVE BEEN REPORTED IN CORRESPONDENCE WITH SOVIET DEPARTMENT. THE SALIENT POINTS HAVE BEEN:
- A) THE ECONOMIST NIKOLAI SHMELYEV, IN THE JUNE ISSUE OF THE LITERARY JOURNAL ''NOVI MIR', AND THE WRITER SHATROV, IN ''MOSCOW NEWS'' NO. 24, HAVE CALLED FOR A RETURN TO THE PRINCIPLES OF LENIN'S ''NEW ECONOMIC POLICY'' AND IMPLIED THAT THE SOVIET ECONOMY HAS BEEN ON THE WRONG TRACK EVER SINCE NEP WAS ABANDONED IN 1929.
- B) SHMELYEV DESCRIBED THE EXISTING SOVIET ECONOMY AS LARGELY UNMANAGEABLE AND ALMOST UNPLANNABLE. HE REFERRED TO THE PRIMITIVE AND IDIOTIC CAMPAIGN AGAINST MIDDLE-MEN SEMICOLON THE ECONOMIC HARM DONE BY ''PARASITIC CONFIDENCE'' IN FULL EMPLOYMENT SEMICOLON PROPOSED FREE ECONOMIC ZONES TO ATTRACT FOREIGN INVESTMENT SEMICOLON AND CALLED FOR AN

- C) AN ARTICLE BY THE MOSCOW UNIVERSITY PROFESSOR G POPOV IN A POPULAR SCIENCE JOURNAL 'NAUKA I ZHIZN' CALLED FOR THE REJECTION OF THE WHOLE 'ADMINISTRATIVE SYSTEM' DEVELOPED UNDER STALIN. ANOTHER ECONOMIST, L POPKOVA (A PSEUDONYM), ARGUED IN A LETTER TO 'NOVY MIR' THAT THE SOVIET UNION HAD A GENUINE SOCIALIST PLANNED ECONOMY BUT IT DID NOT WORK VERY WELL. SHE REJECTED AS MISCONCEIVED IDEAS OF A RETURN TO NEP ON THE GROUNDS THAT AN ATTEMPT TO IMPROVE THE SOVIET ECONOMY BY INTRODUCING A MARKET MECHANISM WAS BOTH UN-LENINIST AND UNWORKABLE. THE MARKET DID WORK AND HAD A FUTURE IN CAPITALIST COUNTRIES BUT WAS INCOMPATIBLE WITH A PLANNED ECONOMY. THE CLEAR IMPLICATION OF HER ARGUMENT IS THAT THE SYSTEM IS A FAILURE.
- 3. AT THE FIRST PUBLIC MEETING ON 29 MAY OF A DISCUSSION CLUB NEWLY FORMED BY A GROUP OF DISTINGUISHED ACADEMICS AND JOURNALISTS THERE WERE FIERCE ATTACKS ON THE STALIN PERIOD BY THE HISTORIAN DR YURY AFANASIEV WHO SPOKE OF THE ''DEATH PANGS'' OF THE STALINIST SYSTEM, AND THE PHILOSOPHER DR BUTENKO WHO REFERRED TO ''BARRACKS SOCIALISM'' AND CALLED FOR THE RESTORATION OF A HUMAN FACE TO SOCIALISM. THERE WERE CALLS FROM THE FLOOR FOR STALIN TO BE DECLARED A STATE CRIMINAL AND FOR THE KGB TO BE BROUGHT UNDER CONTROL.
- 4. THE ECONOMIST SHMELYEV GAVE A TALK ON 10 JUNE AT A MOSCOW INSTITUTE ON THE THEME THAT IMMORALITHH IS ECONOMICALLY INEFFECTIVE AND REFERRED TO THE 17 MILLION PERSONS WHO HAD BEEN THROUGH THE LABOUR CAMPS AND THE 5 MILLION PEASANT FAMILIES DEPORTED DURING COLLECTIVISATION.

5. THE AUTHORS OF THESE RADICAL STATEMENTS ARE NOT MAVERICKS
BUT INFLUENTIAL FIGURES, SOME OF WHOM EVIDENTLY HAVE SUPPORT
IN HIGH PLACES. DR AFANASIEV IS CO-CHAIRMAN OF THE
DISCUSSION CLUB, WITH 1 T FROLOV (UNTIL RECENTLY EDITOR OF
KOMMUNIST AND NOW A GORBACHEV AIDE). PROFESSOR POPOV WAS ONE

AND ON ECONOMIC POLICY REMAINS CAUTIOUS AND RESERVED. THE CENTRAL COMMITTEE SECRETARY, LUKYANOV TOOK A CONSERVATIVE LINE IN A SPEECH PUBLISHED IN PRAVDA OF 16 JUNE IN WHICH HE ENDORSED COLLECTIVIZATION AND INDUSTRIALIZATION AND THE METHODS BY WHICH THEY WERE IMPLEMENTED. AT THE CENTRAL COMMITTEE ECONOMIC CONFERENCE (MYLUELNO 861) GORBACHEV APPEARED TO BE RESPONDING DEFENSIVELY TO APPREHENSIONS ABOUT HOW WIDE-RANGING THE DISCUSSION ON ECONOMIC REFORM HAD BECOME, WHEN HE INSISTED ON THE ONE HAND THAT ALL POINTS OF VIEW SHOULD BE DISCUSSED BUT ON THE OTHER THAT 'ANTI-SOCIALIST SOLUTIONSTS MUST BE REBUFFED. THERE IS NO EVIDENCE THAT HE HIMSELF WOULD ENDORSE THE MORE RADICAL VIEWS WHICH HAVE BEEN RECENTLY

FORWARD. BUT HE MAY SEE ADVANTAGE IN WIDENING
THE SCOPE OF THE DEBATE IN ORDER TO OPEN UP OPTIONS FOR THE
