MEMPT: HUMAN REGHTS HIN AFGHANISTAN

1. FOLLOWING ARE THE MATEN POWNTS TO EMERGE FROM BROWEFFING BY ERMACORA.

PRIMSONS

- 2. ALTHOUGH HE VAISHITED PRINSONS ON ALL THREE CENTRES, ERMACORA ONLY SPOKE TO TWO PRINSONERS (IN PUL-II-CHARKIN: A PROFESSOR ROSSMAN (PHON) AND A FORMER MINNESTER, NFD). HE HAD DECIDED NOT TO QUESTION PRINSONERS AT RANDOM, HAVINING BEEN WARNED BY THE WCRC THAT THIS MINGHT PREJUDINCE THEIR HOPES OF A MORE RINGOUROUS VINSTIT EARLY WAN THE NEW YEAR. NOR DIND HE WINSHIST ON NAMED UNDANYIPULALS BEINING PRESENTED TO HAIM, EVEN THOUGH INCRC HAD SAND THAT WOULD BE ACCEPTABLE, BUT HE HAD SUBMINITED ''A LONG LINSTI' OF NAMED PRINSONERS, ENQUIRIRING ABOUT THEME FATE. HE HAD YET (7 AUGUST) TO RECEIVE A REPLY (COMMENT: PACE HAD TOLD US A FEW DAYS EARLINER THAT PRINSON GOVERNORS HAD ORALLY DENIED KNOWLEDGE OF MANY OF THE NAMES). WAKING, HAD CONFIRMED THAT AN INCRC WOULD BE ALLOWED TO VINSHIT WIN JANUARY AND CONDUCT PRIVATE WINTERVINEWS. ERMACORA WOULD REFER TO THIS SIAN HIPS REPORT.
- 3. ERMACORA SAHD PRHSON CONDHITHONS WERE APPALLHING: OVERCROWDED, UNVENTHILATED AND UNLITE CELLS, WHITH PRHSHITHON EXAMPTATHON AND NO COMFORTS. AT PULL-H-CHARKIN PRHSONERS ONLY HAD 1 HOURS EXERCIPSE A DAY, AND SPENT THE REST OF THE THIME HAN THEMR CELLS. THE EXERCIPSE AREA WAS "VERY SMALL AND HOT": APPARENTLY A LARGE COURT-YARD HAD BEEN SUBDHIVHOED HINTO TEN SMALLER ONES, TO ENSURE PRHSONERS COULD NOT SEE EACH OTHER. WHEN HE EXPRESSED HINS VINEWS TO HIMS HOSTS!, THEY TOLD HIMM NOT TO APPLY WESTERN STANDARDS: THE CONDHITHONS WERE LIMITE WORSE THAN THOSE AFGHANS REGARDED AS NORMAL HIN PRHYATE LIMITE. ERMACORA TOLD US HE WOULD RESERVE JUDGEMENT UNTIL HE HAD BEEN ABLE TO CONSULT HACRC.
- 4. ERMACORA HAD BEEN ALLOWED TO VINSHIT DETENTION CENTRES AT SEDERAT AND SHASHDARAK. ALTHOUGH HE HAD SKETCH MAPS OF BOTH, HE COULD NOT FIND, AND HINS HOSTS DENMED THE EXPISTENCE OF, UNDERGROUND CELLS. HE FOUND NO EVALUENCE OF THE PRACTICE OF TORTURE,

AND SAMED THERE HAD BEEN NO REPORTS OF ANY FOR SOME MONTHS. HOWEVER, HE ADDED, ''YOU COULD DO ANYTHING YOU WANT'' IN THESE PLACES',
AS WELL AS INN OTHER PRINSONS, ALL OF WHITCH HAD MANY CELLARS AND
SMALL ROOMS. HE SAMED THERE WERE MANY PRINSONERS ON REMAND AND THAT
THEY COULD BE HELD WINTHOUT TRIAL FOR UP TO SEVEN MONTHS. HE HAD
DECIDED NOT TO VINSIT THE PULGARIE PRINSON INN S. KABUL WHEN TOLD INT
WAS ONLY A HOLDING CENTRE FOR TRAFFING OFFENDERS. HE HAD VINSINTED THE
HQ OF THE KHAD 5TH BUREAU AT DEHMAZANG INN S. KABUL, BUT FOUND HIT
WAS A GORRINSON, WINTHOUT PRINSONERS.

5. ERMACORA SAND HE HAD BEEN APPROACHED 'CLANDESTANELY' BY
THE ACTIONS GRANMAN CHARGE " WHO ASKED HIMM TO ENQUINE ABOUT THE
FATE OF 300 MRANMANS THOUGHT TO BE SIM PUL-M-CHARKHIN.

RELEASED PRINSONERS

- 6. HE HAD HAD PRIMITATE TALKS WHITH SOME RELEASED PRIMISONERS HINCLUDHING PROFESSOR KAKKAA (PHON) AND KOGADAM (PHON). A FORMER AMMIN MINIMISTER OF JUSTHICE, A FORMER DEPUTY MINIMISTER OF HEALTH, AND A FORMER WHO EXPERT. ALL WERE HIN GOOD SHAPE. THE ACADEMINGS HAD RESUMED THEIR CHAMPAS, AND HAD WRIFTTEN TO 59 EXHLED COLLEAGUES URGING THEM TO RETURN (COMMENT: ERMACORA ADMINITED, SIAN REPLY TO A QUESTMON, THAT KAKKAA HAD NOT REPEAT NOT ASKED HIMS FAMILY TO RETURN FROM PESHAWAR, ON THE GROUNDS THAT HIMS SONS WERE MIND-WAY THROUGH UNBIVERSHITY COURSES). ALL THE RELEASED PRIMISONERS HE SPOKE TO SUPPORTED NATHONAL RECONCIPLINATION.
- 7. ALTHOUGH HE HAD PERMINSHON TO DO SO; ERMACORA HAD NOT BEEN ABLE TO MINTERVMEW 56 PRINSONERS RELEASED FROM PUL—MI—CHARKHIH ON THE DAY OF HIMS VHISHT; BECAUSE THEY COULD NOT BE TRACED.

HOSPINTALS

8. ERMACORA FOUND FEW CHRYMALMAN (WOMEN AND CHMALDREN) PATHEBTS
HIN THE HOSPINTALS HE VHISHITED. THERE WERE 12 HIN A 400 BED HOSPINTAL
HE VHISHITED, 105 HIN ANOTHER. THE HINJURHES HE SAW WERE MUCH LESS
SEVERE THAN THOSE HE HAD ENCOUNTERED HIN PAKINSTAN. MANY PATHENTS
SEEMED TO BE BEHING TREATED FOR INNJURHES SUSTAINED UP TO 2 YEARS
AGO. THERE WAS NO EVINDENCE OF HINJURHES BEHING CAUSED BY CHEMHICAL
OR SHIMMLAR WEAPONS. DOCTORS ASSURED HIMM ALL PATHENTS WERE TREATED
HIN THE SAME WAY, WHITHOUT DHISCRHIMMINATHON. HE ASKED ABOUT MUJAHEDDHIN
AND WAS SHOWN 6 PATHENTS. THEY WHILL FACE LEGAL ACTIMON ON DINSCHARGE.
MEANWHINELE THEY ARE DENINED FAMMLY VINISHTS OR CORRESPONDENCE. ERMACORA
WAS UNSURE WHETHER THIS WAS A VINOLATIMON OF THEHER HUMAN RHIGHTS.

RELINGHION

9. ERMACORA SAMD HE WAS SATHESPHED THAT THE PRHINCIPLE OF FREEDOM OF RELANGINON WAS RESPECTED MIN AFGHANMISTAN. HE ADDED, HOWEVER, THAT THE MULLAHS HE SPOKE TO WERE ALL FROM THE 18,000 WHO RECEMBED GOVERNMENT SALARMES. HE HAD ALSO NOTWICED THAT ALL THE MOSQUES HE VAIGHTED HAD PROMINENTLY DIMSPLAYED POSTERS EXTOLLINING NATIONAL RECONCIPLINATION. LACK OF THIME, HE SAMD, PREVENTED HAM SEERING THE DEVASTATED AREAS OF HERAT. HE WAS TOLD THE DRA HAD FORENMIC PROOF THAT THE DAMAGE TO THE MOSQUE THERE HAD BEEN CAUSED BY THE

NATHONAL RECONCINUMENTATION CONTINUED TO WHICH ALL HIMS HINTERLOCUTORS, NOT JUST RELEASED PRINSONERS (PARA 6 ABOVE) INMISSISTED
THAT NATHONAL RECONCINUMENTION WAS THE ONLY WAY TO PROCEED. SOME
REFORMED MUJAHEDDIN HE MET HIN HERAT HAD ALL SAND THEY WOULD
NOT HAVE SURRENDERED HIF HIT HAD NOT BEEN FOR NR. THE MULLAHS WERE
STRONGLY INN HITS FAVOUR. ERMACORA CONCEDED, HOWEVER, THAT NR WAS,
LHIKE MOTHERHOOD, AN UNDENHABLY GOOD THANG AND THAT HITS HIMPLEMENT—
ATHON WAS MORE HAMPORTANT THAN THE PRINNCIPLE. HE TOOK NOTE OF OUR
ARGUMENT THAT SELF DETERMINATION COULD ONLY FOLLOW; NOT PRECEDE
SOVERET WHITHDRAWAL BUT THAT REGIME/SOVINET PROPAGANDA HAD MANAGED
TO REVERSE THE ORDER; USING NR AS A EUPEMINISM FOR, ALTERNATIVELY;
"'PEACE'' AND SELF DETERMINATION.


11. EMACORA COLUNTEERED THAT MANY OFF-MCMAL PREMMISES HE VINISHTED WERE REPLETE WHITH MARXHISTS AND DRA/SOVMET FRIMENDSHIP POSTERS; ALTHOUGH OFF-MCMALS DENMED THINS WAS A COMMUNIMIST COUNTRY. HE SAMD THE DRAFT CONSTINTUTION WAS "VERY NIMICE" BUT SHOT THROUGH WANTH LOOPHOLES TO PERMINT LEGALINISED TOTAL MITARINA NIMISM.

REFUGEES

- 12. DRA OFFRICINALS HAD MADE THE STANDARD ALLEGATIONS ABOUT WARANSHAN AND PAKSISTANS EFFORTS TO PREVENT REFUGEES RETURNING. THE OFFSIONALS HAD HOWEVER SAND THAT WHILE REFUGEES SON MERAN WERE BESING BAULKED BY GOVERNMENT ACTION, THOSE IS NO PAKSISTAN'S EFFORTS TO RETURN WERE BESING FRUSTRATED BY THE MUJAHEDDISH AND MULLAHS. ERMACORA SAND HE BELISEVED THE MAJORISTY WHO HAD RETURNED FROM PAKSISTAN WERE ENTHER HERE ONLY TEMPORARSHY OR HAD FAISLED, FOR ONE REASON OR ANOTHER, TO BE SINCLUDED ON THE UNHER REGISTER.
- 13. ##N REPLY TO QUESTHONS, ERMACORA SAMED ##NDMA (SMC) AND BRRAN HAD CONSMISTENTLY DENIMED HMM ACCESS TO AFGHAN REFUGEES ##N THOSE COUNTRMES. HE WOULD CONTINUE TO PRESS. HE TOOK NOTE OF OUR SUGGESTMON THAT MINDMA'S CONCERN WAS PROBABLY THAT MOST AFGHANS THERE WERE WELL EDUCATED AND MODERATELY WELL OFF; AND MINGHT GMAYE HIMM THE 'WRONG'' ANSWERS ABOUT WHY THEY HAD GONE THERE MMN THE FMIRST PLACE AND WHY THEY WOULD NOT RETURN.

MINLENTARY AND POLINTENCAL SWITUATION

14. ERMACORA SAMD THE ROAD MENTO HERAT FROM THE AMPRORT WAS HEAVALY PROTECTED, WHITH TANKS STATMONED EVERY 200 METRES, POMINIMANG WEST, AND MANY STRONGLY FORTHERNED POSTS. MIN MAZAR, THE DEFENCES WERE LESS OBVINOUS, BUT 'MANY'' MMH.MITARY WERE ON DUTY MAN THE STREETS. HE BELMEVED THEY WERE FROM THE 18TH (AFGHAN) MINFANTRY REGMMENT. OFFINCHALS MAN BOTH PROVINCIBAL CHITMES ADMINITED THEY DIMD NOT CONTROL THEME RITMER REGMON, BUT WERE EVASMIVE ABOUT THE LOCATMON OF THE MUJAHEDDMIN (ALTHOUGH MIN HERAT THE AUTHORITMES SAMD WIT WAS NOT POSSMBLE TO VINSMIT THE WORST DAMAGED MOSQUE). ERMACORA HAD





ALSO BEEN TAKEN TO SOME SELF DEFENCE UNINTS, AND MENTHONED ONE AT BAGRAMM, ON THE OUTSKINGTS OF KABUL, INN PARTHICULAR. THEY SEEMED SECURE AND WELL ORGANINED (COMMENT: THE PAKHISTANIN CHARGE SUGGESTED TO HIMM THEIS WAS BECAUSE THEY HAD AN ARRANGEMENT WHITH THE MUJAHEDDINN). AT BAGRAMMI THEY HAD BEEN UNABLE TO EXPLAIN TO HIMM THE HEAVY NIGHT THIME ARTHILLERY BARRAGES AROUND KABUL.

15. NONE OF US WAS ABLE TO GMYE ERMACORA A DETAMMED ASSESSMENT OF THE STATE OF THE FMMHTMING OUTSMIDE KABUL BUT (SPEAKMING PERSON-ALLY) MESAMD THE STALEMATE SEEMED TO BE GETTMING MORE EXPENSIVE FOR BOTH SMIDES; MIN TERMS BOTH OF MANPOWER AND MATERNAL!, PARTLY AT LEAST BECAUSE OF THE MINCREASED USE OF STMINGER.

MISCELLANEOUS

- 16. ERMACORA HAD HAD NO OFFHICHAL CONTACT WHITH SOMET OFFHICHALS OR MINLHITARY. HE HAD MET THE CHARGE' AND ONE OTHER DIMPLOMAT AT RECEPTHONS ON 2 AND 4 AUGUST, AND AN ADVINSER AT ONE HOSPHITAL HE VINSHITED. HE HAD BEEN TOLD THERE WERE SOMET ADVINSERS HAN MOST HANSTHITUTHONS. HE HAD ALSO BEEN ACCOMPANHED TO HERAT BY A SOMHET JOURNALINST, BUT DIED NOT GRIVE HERM AN WINTERVINEW.
- 17. ERMACORA SAND, HAN COMMENTHING ON STORMES OF UNDER-AGE RECRUMET-

MENT TO THE ARM ANDPRESS GANGS, THAT HE HAD SEEN ''MANY'' YOUNG PEOPLE ON THE STREETS. THE PAKINSTAN CHARGE' SAMD THESE WERE PROBABLY FROM MINFLUENTHIAL FAMILIHES OR HAD OTHER FORMS OF EXEMPTIMON (EG STUDENTS).

- 18. HE DESCRIBED THE WATAN NURSERY AS ''A CLEAR CADRE-BUHLDHING ELEMENT'' AND CONFESSED TO EMBARRASSMENT ABOUT HIPS VAISHIT TO YOUNG PHONEERS. HE HAD CALLED ON GOVERNMENT AND PARTY LEADERS, AND OTHER HINFRASTRUCTURAL HINSTHITUTHONS, EG WOMEN'S GROUPS. HE REPORTED MANY HINTERLOCUTORS AS BEIFING STRONGLY HOSTBILE TO HEKMATYAR. HE WAS ACCOMPANHED ON MOST VAINSHITS BY A TV CREW, AND HHIS OFFICEMAL ESCORTS HINCLUDED THREE MFA OFFICEHALS (HEAD OF UN DRIVANSHON, MEMBERS OF PROTOCOL AND HIMFORMATHON DEPARTMENTS) AND A PARTY HINFORMATHON OFFINCER. NONE HAD TRHEED TO HIMPOSE ON HHIM. HIN FACT, THE GOVERNMENT HAD ACCEEDED TO ALL HHIS WHISHES (''NOT ONE WAS UNFULFHILLED'') AND BEEN COURTEOUS AND HELPFUL THROUGHOUT.
- 19. THE VHISHIT TO MAZAR WAS SUBSTRUTUED AT THE LAST MEMBUTE FOR A PLANNED TRUP TO KHOST. THE AUTHORITHES TOLD ERMACORA THAT RECENT RANNS HAD MADE THE RUNWAY UNSAFE FOR HIS CHARTERED BAKHTAR AMPRICAFT.

20. ERMACORA MASSUED A PRESS STATEMENT MAMMEDHATELY BEFORE DEPARTURE. TEXT HIN MAMET.

THE FUTURE

21. ERMACORA MINTENDS TO VINSHIT PAKHISTAN MIN EARLY SEPTEMBER; AND WHILL THEN PREPARE A REPORT FOR UNGA. HE WAS CONVINCED THE FACT AND SUBSTANCE OF HIMS VINSHIT WOULD BE EXPLONITED BY THE REGIMME/SOVINETS; BUT HOPED HE WOULD GET THE BALANCE RINGHT WIN HIMS REPORT. HE HAS NO FINXED PLANS TO RETURN; BUT WOULD EXPECT TO DO SO BEFORE THE HUMAN RINGHTS COMMINISSIMON MEETS NEXT YEAR. MF SO, HE WOULD LINKE TO VINSHIT OTHER PROVINCES; AND AREAS NOT UNDER DRA CONTROL.

HUMAN RHIGHTS IN AFGHANISTAN

SUMMARY

1. THE UN SPECHAL RAPPORTEUR ON HUMAN RWIGHTS WHISHTED KABULY, HERAT AND MAZAR—IN-SHARMF BETWEEN 30 JULY AND 8 AUGUST. ERMACORA SAWD THE DRA HAD ACCEEDED TO ALL HIMS PROGRAMME REQUESTS, ALTHOUGH (AT RED CROSS URGHING) HE DWID NOT SEEK RANDOM WHITERWINEWS WHITH PRIMSONERS. MOST OF THOSE HE SPOKE TO (WINCLUDING RELEASED PRIMSONERS) PRAWISEDNATHONAL RECONCIMUMATION. ALTHOUGH HE MAY HAVE FULFWILLED HIMS WITSHNERARY, ERMACORA'S WINSPECTHONS WERE PERFUNCTORY. HE RECONGIMENSED THAT THE DRA WOULD EXPLOYED HIMS WISHT; BUT MAY WELL NOT HAVE REALMSED THAT HE GAVE SEVERAL POLITHICAL HOSTAGES TO FORTUNE.

DETAHL

2. PROFESSOR FELHIX ERMACORA (AUSTRIMA); THE UN SPECHAL RAPPORTEUR ON HUMAN RHIGHTS!, VINSHITED AFGHANISTAN FROM 30 JULY TO 8 AUGUST; HE SPENT MOST OF HIMS THIME HIM KABUL!, BUT HAD A DAY EACH AT HERAT AND MAZAR-HI-SHARHIF. ON 7 AUGUST HE ATTENDED A DIMINER WHITH NATO; CHINNESE; PAKHISTAN AND AUSTRIMAN CHARGES; TO BRINGE THEM ON HIMS EXPERIMENCES AND HIMPRESHIONS. HE WAS OVER AN HOUR LATE; WAS CLEARLY VERY THRED; AND HAD NOT HAD THIME PROPERLY TO MARSHALL HIMS THOUGHTS. WHITTH HOUDERS SOME ORDER ON WHAT WAS HIM FACT A PRETTY HINCHOATE DIMISCOURSE. HIT WOULD BE HELPFUL HIF UKMINS GENEVA WOULD FOLLOW UP WHITH JOHN PACE; TO VERHIP OR AMEND THE ACCOUNT HIM MINITT AND TO OBTAINN A READ OUT ON ERMACORA'S MEETHINGS ON 8 AUGUST. THE PRESS STATEMENT HISSUED BY ERMACORA ON DEPARTURE HIS HIM MY SECOND HIFT.

COMMENT

3. ALTHOUGH ERMACORA #S AWARE THAT THE #MAGE HE WAS GHIVEN WAS; #F NOT SQUEAKY CLEAN; NO WORSE SUPERFICEHALLY THAN MANY OTHER THRED WORLD COUNTRIES; AND THAT THRES WHILL HAVE TO BE REFLECTED #M HIMS REPORT; HE SOUGHT TO GROVE THE **MMPRESSHON TO US THAT HIMS CONCLUS—**MONS; ESPECHALLY AFTER HIMS WISHIT TO PAKHISTAN; WOULD BE ALONG THE RINGHT LIMIES. #M AM LESS CONFIDENT. AS MIRSS YOUNG PORMITED OUT HIM HER LETTER OF 8 JULY TO SHINTON (SAD); "' EXPERIMENCE SHOWS THAT COUNTRINES UNDER CONSINDERATHON GET A MORE FAVOURABLE REPORT ONCE THEY LET THE SPECHAL RAPPORTEUR **MM**. ERMACORA'S REPORT WHILL CONTAIN MORE THAN ENOUGH TRIBUTES TO THE HELPFULNESS OF THE DRA.

NOT TO MENTHON VAGUE PROMHSES OF MORE DETAINL AS A RESULT OF A FURTHER VAISHT, FOR DRA AND SOMMET LOBBYMSTS TO BE ABLE TO ARGUE ENTHER THAT AN UPBEAT UNGA HUMAN RINGHTS TEXT SHOULD BE PREPARED, OR THAT DELEGATIONS SHOULD REJECT ANY WESTER-INSPIRED CRITICOUSMS.

ENTHER WAY, THERE WHILL BE KNOCK-ON CONSEQUENCES FOR THE UNGA
PLENARY VOTE ON THE AFGHAN RESOLUTION.

- MY AUSTRIMAN COLLEAGUE HAS TOLD ME ERMACORA HIS A ! CRAFTY OLD FOX''. HE CERTAHINLY RECOGNINSED THAT HIMS VINSINT WOULD BE EXPLONTED HIN SOME WAY OR ANOTHER. HIT MAY THEREFORE BE THAT ERMACORA AND HIMS ENTOURAGE WHILL RATHIONALITISE THEFT ACTION AND COMMENTS AS DESMENED TO PLAY THE HUMAN RAIGHTS MISSUE LONG , AND KEEP THE DOOR OPEN FOR A MORE SUBSTANTING VINSINT LATER. INF SO: THEMER SMINGLE-MAINDED DETERMANATION TO STARCK TO HUMAN RAIGHTS QUEST-THONS HAS BLANKERED THEM TO THE HAMMEDHATE POLSATHICAL REALINITHES. THE FACT OF THE VHISSMT ALONE RIMSKED A DIRMINNUTIMON OF ANTIN-REGIMME SENTHMENT AT UNGA. ERMACORA'S ASSERTHONS THAT HE RECEIVED FULL COOPERATINON, HANS FAMILURE TO FRIND SUBSTANTINVE FAULT, AND HIMS AMBRIGUOUS BUT QUOTABLE ENDORSEMENT OF NATIONAL RECONCIPLINATION VARTUALLY GUARANTEE HAT. AS SOON AS ERMACORA DECADED TO VALSHAT. THE REGISHE WAS THE A NO-LOSE SENTUATION. HET HIS NO DOUBT NOW CONGRAT-LILATING HITSELF THAT HIT HAS HIN FACT GAMMED FURTHER PROPAGANDA ADVANTAGE.
- 5. ERMACORA ALSO SEEMS TO HAVE FAMILED TO THRINK THROUGH SOME OF THE THINNGS HE WAS TOLD AND SOME OF HIMS ACTIVONS, EG:
- (A) GIVEN THE SHORT THEME AVAILABLE, AND THE PRACTICAL DIMFFICULTHES
 HIN VINSHITHING THE COUNTRYSHOE, ERMACORA SHOULD HAVE CONCENTRATED
 ON PRISONERS (THE MAJOR ALTERNATHVE SOURCE OF HINFORMATHVON ON
 HUMAN RHIGHTS VIOLATHONS), RATHER THAN SPEND SO MUCH THIME WHITH
 REGITME OFFICIALS AND APOLOGISTS.
- (B) HE TOOK TOO MUCH FOR GRANTED IN ACCEPTIONS INCRC CONFINDENCE
 THAT THEMER PROTECTION TEAM WINLL BE ALLOWED BACK AND THAT,
 EVEN INF HIT INS, I INT WINLL ACHIEVE ANY MORE THAN LAST THIME.
- (C) HE SEEMED UNCLEAR HOW MCRC CAN COMMENT ON PRHISON CONDUCTIONS
 WHEN THEY HAVE NOT BEEN ALLOWED TO VENSHIT.
- (D) HE UNCRIMINATION ACCEPTED THE EXCUSE FOR THE CANCELLATIFON OF THE VIRSHIT TO KHOST, WHINCH WAS ALMOST CERTAINNLY FABRIFICATED. EVEN THE LOCAL MEDINA REPORTED FINGHTHING IN THE AREA AT ABOUT THE SAME THAME. AND THAT INS MORE LINKELY TO BE THE REASON.
- (E) HAT WAS NAHVE TO ACCEPT THAT PULGARNINGS A DETENTION CENTRE
 FOR TRAFFINC OFFENDERS. THERE ARE NO SUCH THINGS AS PARKHING TINCKETS
 HIN KABUL, AND WE HAVE NEVER SEEN ANYONE UPBRAHDED, LET ALONE
 ARRESTED FOR A DRHAVING OFFENCE. THERE ARE NO DRHAVE LAWS.

 DEHMAZANG CERTAINLY USED TO CONTAINS A KHAD PRISON.

6. ALTHOUGH ERMACORA MAY HAVE HINTENDED HIMS PRESS STATEMENT TO
BE FACTUAL, AND TO RESERVE JUDGEMENT UNTIFIL AFTER HIMS VINSHIT TO
PAKHISTAN, HE HAS GAIVEN SOME HOSTAGES TO FORTUNE, EG

(A) UNCRHTHECAL (AND UNECESSARY) REPETHITHON OF SOWHET REVERSAL OF THE FACTS ON BOOBY TRAPPED TOYS (PARA 2).

(B) THE PERHAPS UNMENTENTIMONAL HAMPLA CATHON MAN PARAGRAPH 3 THAT HE
MET ALL SHADES OF OPHANNON, WHEN IN FACT NONE OF HAS HINTERLOCUTORS
VOLUNTEERED COMMENTS CRITITIONAL OF THE REGIMME.

(C) THE UNECESSARMLY FULSOME PRAMSE OF DRA COOPERATMON (PARA 4);
WHITH ONLY A PASSMING REFERENCE (MIN PARA 6) TO THE BACKGROUND
TO HIMS VINSINT.

(D) THE REFERENCE TO 'RECONCHRUHATHON' AS A POSHITATIVE STEP (PARA 5 5), COUPLED WHITH THE MAYPLANCATHON THAT MEASURES TAKEN SO FAR WERE ON THE RANGHT LAMIES.
