

Visit to the UK of Dr Koryagin

Thank you for your letter of 1 October asking for advice on the suggestion from David Atkinson MP that the Prime Minister should see Dr Koryagin during his visit to the UK in December.

Dr Koryagin, a Soviet psychiatrist, has played a leading role in exposing the abuse of psychiatry in the Soviet Union. He produced a paper on the practice which was widely publicised in the West, including in "The Lancet" in 1981. Following his revelations, the Soviet Union eventually withdrew from the World Psychiatric Association (in 1983) in response to calls for their expulsion. In 1981, Koryagin was arrested, charged with 'anti-Soviet agitation and propaganda" and sentenced to 7 years in a labour camp and 5 years in internal exile. He undertook hunger strikes in 1982, 1984 and 1985, when a further 2 years in camp was added to his sentence for "resisting authority".

Dr Koryagin's case aroused great concern in the West. His name figured frequently on lists of cases of Soviet abuses of human rights. Along with a number of other political prisoners, he was finally released in February this year. His son Ivan, who had also been imprisoned, was released in March. The family were allowed to emigrate to Switzerland In April.

Soviet abuse of psychiatry is a particularly pernicious practice and one which is continuing. Although fewer people have been committed to psychiatric hospitals for their beliefs since Mr Gorbachev came to power, releases have been relatively few compared to the numbers of those allowed out of prison or labour camps. Human rights organisations in the West continue to be particularly concerned about this subject.

Following her previous meetings with Dr Orlov and Natan Sharansky we think it would be appropriate for the Prime Minister to receive Dr Koryagin also. This would allow her to pay tribute to Dr Koryagin's courageous contribution to the cause of human rights in the Soviet

Union and to assure him of our continuing concern at the abuse of psychiatry in that country. At a time when the current CSCE meeting in Vienna will be approaching its climax, a meeting would serve as a useful reminder to the Russians and others that there is no reduction in the level of our interest in and criticism of unacceptable Soviet practices.

Dear Archie,

Dr. Anatoly Koryagin will be visiting the UK during the week beginning 2nd November to address the AGM of the UK branch of the International Society on Human Rights (ISHR), of which I am President, on Wednesday evening 4th November.

As you will know, Dr. Koryagin, himself a psychiatrist, became one of the most famous names of those campaigning against the misuse of psychiatry in the treatment of political prisoners in the Soviet Union, and was finally released after a world-wide campaign on his behalf in February this year after 7 years in the Gulag.

I am sure that the Prime Minister would wish to meet Dr. Koryagin at Number 10 whilst he is here, and I wondered if this could be arranged any time during Tuesday 3rd November, Wednesday 4th November, or after Prime Minister's Question Time on Thursday 5th November, or during Friday morning 6th November.
