IT WAS THEIR FIRST MEETING, AND INCLUDED 15 MINUTES TETE A TETE. 3. PEREZ DE CUELLAR TOLD ME AFTERWARDS HE THOUGHT IT HAD BEEN A VERY GOOD MEETING. VASSILIOU WAS A REFRESHING CHANGE FROM KYPRIANOU.
