GORBACHEV'S UN SPEECH : HUMAN RIGHTS.

- 1. GORBACHEV'S STATEMENT THAT THERE WERE NO LONGER ANY PEOPLE IN THE SOVIET UNION IMPRISONED FOR THEIR POLITICAL OR RELIGIOUS CONVICTIONS HAD BEEN WIDELY EXPECTED. IT MAY BE SIGNIFICANT THAT THE LANGUAGE APPEARS TOSBE MORE RESTRICTIVE THAN THE PHRASEP''THOSE WHOM THE WEST REGARDS AS POLITICAL PRISONERS'' WHICH HAD BEEN USED TO THE GERMANS DURING THE KOHL VISIT. IT IS ALSO NOT CLEAR WHETHER HIS STATEMENT APPLIES TO PSYCHIATRIC HOSPITALS. WE WILL TRY AND TOUCH BASE WITH THE US EMBASSYSANC WITH UNOFFICIAL POLITICAL ACTIVISTS HERE WOR THEIR ASSESSMENT OF HOW THIS STATEMENT SQUARES WITH PRACTICE TO DATE. ON 7 DECEMBER THE US EMBASSY HAD ONLY HEARD OF THREE RECENT RELEASES OF POLITICSL PRISONERS.
  - 2. THE OTHER MAIN POINT IN GORBACHEV'S REMARKS ON HUMAN RIGHTS WAS HIS ACCEPTANCE OF A TIME LIMIT FOR APPLICATION OF THE SECRECY RULE TO WOULD-BE EMIGRANJS. THE LENGTH OF THIS TIME LIMIT MAY IN PRACTICE EMERGE FROM NEGOTIATION IN VIENNA. THE RUSSIANS HAVE ALREAD# ANNOUNCED THAT THEY INTEND TO LIFT SECURITY RESTRICTIONS ON 120 CASES, AND, AS WE HAVE REPORTED, SOME 50 REFUSENIKS HAD ALREAD BEEN INFORMED OF THIS BY 6 DECEMBER. ACCORDING TO THE LATEST LIST PROVIDED TO US HERE BY REFUSENIK CONTACTS THIS WOULD STILL LEAVE SOME 50 REFUSENIKS DENIED VISAS ON SECRECY GROUNDS AND A FURTHER 120R SO DENIED VISAS FOR OTHER REASONS, EG. THE ''POOR RELATIVES'' CLAUSE.
