"MR. DENIS HEALEY, CHIEF OPPOSITION SPOKESMAN ON FOREIGN AND COMMONWEALTH AFFAIRS (LEEDS, EAST, LAR.)

IS NOT ODD THAT MR. LUCE DID NOT REFER TO THE ARGENTINE PARTY PLANTING THE ARGENTINE FLAG ON THE ISLAND?

AFTER HIS TALKS WITH THE ARGENTINE REPRESENTATIVES IN NEW YORK RECENTRLY THE ARGENTINE GOVERNMENT SAID THAT UNLES GOT A SATISFACTORY AGREEMENT IT WOULD TAKE UNILATERAL ACTION. HAS HE ANY EVIDENCE THAT THE RECENT ACTION WAS IN FULFILMENT OF THAT THREAT?

MR: LUCE:

FOR A SHORT PERIOD THE ARGENTINE FLAG WAS PLANTED, LT HAS BEEN REMOVED.

ON THE NEW YORK TALKS, THE ATMOSPHEFE WAS IN A GOOD SPIRIT : AND WAS NOT ABOUT THE SUBSTANCE OF THE ISSUE BUT ABOUT HOW WE CAN ADOPT PROCEDURES TO DISCUS THE DISPUTE IN THE LONGER TERM.

SINCE THEN, I REGRET THAT SOME ACTION HAS BEEN TAKEN WHICH HAS NOT CREATEDA HELPFUL ATMOSPHERE. IN THAT CLIMATE IT IS NOT SENSIBLE TO DISCUSS MAKING FURTHER PROGRESS.
