1. I SAW MR TINDEMANS THIS MORNING. AFTER THANKING HIM FOR THEIR
RESPONSE IN CALLING IN THE ARGENTINIAN AMBASSADOR ON FRIDAY, AS I
HAD ASKED, (TINDEMANS SAID HE HAD NOT YET RECEIVED A FULL ACCOUNT

OF WHAT THE AMBASSADOR HAD SAID TO TROUVEROY) I SPOKE ON THE LINES
INSTRUCTED, ASKING IN PARTICULAR FOR ACTION BY THE BELGIAN GOVERN-
MENT ON THE THREE POINTS IN PARA 5 OF TUR.

2. TINDEMANS SAID THAT HE SHARED OUR VIEW THAT THIS WAS A MATTER
OF THE GREATEST IMPORTANCE AND THE BELGIAN GOVERNMENT WOULD DO
EVERYTHING IT COULD TO HELP US. HE WOULD REPORT MY REPRESENTATIONS
TO THE CABINET AND THEY WOULD EXAMINE WHAT COULD BE DONE. I URGED
THAT IN THE MEANTIME THEY MIGHT CONSIDER PUTTING OUT SOME STATEMENT
TO INDICATE THAT ACTION WAS BEING CONSIDERED: HE SAID HE THOUGHT
THAT THIS COULD BE MANAGED. HE ASKED WHETHER WE WERE CONSIDERING
ACTION IN THE COMMUNITY. I CONFIRMED THAT WE WERE AND THAT, ALTHOU-
GH WE HAD NOT DECIDED ON THE PRECISE FORM THE MEASURES WE WOULD
PROPOSE MIGHT TAKE, WE WOULD SHORTLY BE APPROACHING THE PRESIDENCY
WITH A REQUEST FOR A MEETING OF COREPER LATER THIS WEEK. HE WELCOMED
THIS.

3. THUYSBAERT, WHO WAS PRESENT, ASKED WHETHER WE WERE CONSIDERING
ACTION ALSO IN POLITICAL COOPERATION. I REPLIED THAT WE WERE

THIS SEEMED TO SECURE THE POSITION THERE FOR THE MOMENT BUT CLEARLY WE COULD NOT EXCLUDE FURTHER ACTION IN THIS CONTEXT IF THIS SEEMED APPROPRIATE. HE SUGGESTED THAT A CALL FOR MODERATION BY THE PARTIES CONCERNED MIGHT BE HELPFUL. I REPLIED THAT THIS HARDLY SEEMED APPROPRIATE IN THE CIRCUMSTANCES, THOUGH WE NATURALLY DESIRED A DIPLOMATIC SOLUTION: WHAT WAS NECESSARY WAS THE MOBILISATION OF OPINION ON SUCH A SCALE AS TO CONVINCED THE ARGENTINIANS OF THE FULL CONSEQUENCES OF THEIR ACTION AND OF THE NEED TO COMPLY WITH THE SECURITY COUNCIL RESOLUTION.

ARGENTINA IS A MEMBER OF THE NON-ALIGNED MOVEMENT, AND THOUGH
NOT (NOT) A MEMBER OF THE UNITED NATIONS, MAY TRY TO
OBTAIN A RESOLUTION OF THE SECURITY COUNCIL FAVORABLE TO HERSELF,
SHEETS TO THE SECURITY COUNCIL, HER AGENT ON THE SECURITY
COUNCIL, TO OBTAIN TO BRING GOVERNMENTS, YOU ARE
RECOMMENDED TO AVOID THE ADOPTION OF A STATEMENT BY
THE SECURITY COUNCIL, DESPITE ARGENTINA'S ACTION
TO OBTAIN THE USE OF FORCE TO RESTORE THE
SITUATION, AND TO STIMULATE A STATEMENT OURSELVES
TO OBTAIN CERTAINLY TO OBTAIN (NOT LEAST BECAUSE

YOU SHOULD ALSO CLOSE TO THE BUREAU AND SEEK TO
