- 1. WE SHOULD BE GRATEFUL IF YOU WOULD TAKE AN EARLY OPPORTUNITY TO SPEAK TO THE AMERICANS ALONG THE FOLLOWING LINES:
  - A. THERE HAS BEEN AN INDICATION FROM AN ARGENTINE
    NAVAL SOURCE THAT SOME THOUGHT MAY BE BEING
    GIVEN TO THE POSSIBILITY OF ACTION BY ARGENTINE
    MILITARY PERSONNEL AT THEIR ANTARCTIC STATIONS
    AGAINST BRITISH STATIONS IN THE ANTARCTIC TREATY
    AREA.
  - B. WE HAVE NOT BEEN ABLE TO ASSESS THE RELIABILITY OF THIS REPORT BUT FEEL THAT WE HAVE NO OPTION BUT TO TAKE IT SERIOUSLY.
  - C. IN OUR VIEW ANY ACTION AGAINST OUR STATIONS BY
    ARGENTINA WHICH COULD BE REGARDED AS NON-PEACEFUL,
    OR AS A MEASURE OF A MILITARY NATURE, WOULD INVOLVE
    A BREACH OF ARTICLE I OF THE ANTARCTIC TREATY.
    SUCH ACTION WOULD ALSO INVOLVE A BREACH OF
    ARTICLE II OF THE TREATY INSOFAR AS IT WAS A
    DENIAL OF THE FREEDOM OF SCIENTIFIC INVESTIGATION. WHILE SUCH ACTION WOULD PRESUMABLY
    BE AIMED AT SUPPORTING OR RE-ASSERTING THE
    ARGENTINE CLAIM TO TERRITORIAL SOVEREIGNTY IN
    OPPOSITION TO OUR OWN (ALL BRITISH STATIONS

LIE WITHIN THE AREA OF THE ARGENTINE CLAIM),
ANY SUCH EFFECT WOULD BE LEGALLY INEFFECTIVE
SINCE ARTICLE IV, PARAGRAPH 2, PROVIDES THAT
NO ACTS OR ACTIVITIES TAKING PLACE WHILE THE
TREATY IS IN FORCE SHALL CONSTITUTE A BASIS
FOR ASSERTING, SUPPORTING OR DENYING A CLAIM
TO TERRITORIAL SOVEREIGNTY IN ANTARCTICA, OR
CREATING ANY RIGHTS OF SOVEREIGNTY IN ANTARCTICA.

- D. WE BELIEVE THAT ANY NON-PEACEFUL ACTION AGAINST
  BRITISH STATIONS WOULD STRIKE AT THE HEART OF
  THE ANTARCTIC TREATY IN A MANNER THAT NONE OF
  THE PARTIES TO THE ANTARCTIC TREATY, WITH THE
  POSSIBLE EXCEPTION OF THE SOVIET UNION, WOULD
  WELCOME.
- E. WE BELIEVE THAT IT WOULD BE PREFERABLE TO DRAW
  THE ATTENTION OF THE ARGENTINES TO THE POINTS
  MADE IN PARAS C AND D ABOVE NOW RATHER THAN TO
  WAIT UNTIL ANY HARDER EVIDENCE COMES TO HAND.
  HMG WOULD THEREFORE BE GRATEFUL IF THE UNITED
  STATES GOVERNMENT, ACTING AS THE DEPOSITARY
  FOR THE ANTARCTIC TREATY, COULD DRAW THESE POINTS TO
  THE ATTENTION OF THE ARGENTINE GOVERNMENT AND
  SEEK FROM THEM ASSURANCES THAT NO ACTION WOULD
  BE TAKEN AGAINST BRITISH STATIONS IN THE ANTARCTIC
  TREATY AREA.
- 2. IF THE AMERICANS FEEL ABLE TO TAKE ACTION ALONG THE LINES PROPOSED, THE SOONER IT CAN BE DONE THE BETTER.
