OPERATION CORPORATE

ITEM 1. PLANNING FOR SURFACE AND AMPHIBIOUS FORCES OPERATIONS

- 1. SIR TERENCE LEWIN said they would wish to discuss the draft Directive (1) which had been prepared in accordance with their instructions (2). He said they would wish to separate those operations envisaged against South Georgia (Operation PARAQUET) from those against the Falkland Islands (Operation SUTTON).
- 2. In discussion the following points were agreed:
 - ${\tt a.}$ Operations should be carried out in three phases:
 - (1) Consolidation of the Exclusion Zone (3) by utilising surface forces, in conjunction with the SSNs to establish control of both sea and air in the Zone.
 - (2) Repossession of South Georgia.
 - (3) The establishment of a position to repossess the Falkland Islands, if necessary.
 - b. The Carrier Battle Group, at present, should remain together and proceed at best speed towards the Exclusion Zone, in advance of the total Task Force.
 - c. A draft Directive for Operation PARAQUET would now be required. The aim in this Directive should be to repossess South Georgia, as soon as possible, utilising only the Forces which had already been assigned for this operation. However if, in the event, intelligence indicated that a reappraisal

was necessary following a build up of Argentine Forces in South Georgia then this operation would have to be reviewed to establish the force levels required.

- d. A draft Directive for planning the repossession of the Falkland Islands (Operation SUTTON) would also be required once an appreciation had been completed.
- 3. Summing up, SIR TERENCE LEWIN said they would wish to agree that the Navy Department should issue orders now to the Carrier Battle Group to move at best speed towards the Exclusion Zone.
- 4. Concluding, SIR TERENCE LEWIN said they would wish to instruct:
 - a. The Assistant Chief of the Defence Staff (Operations), in conjunction with the Assistant Chief of the Defence Staff (Policy), to prepare a draft Directive to the Commander-in-Chief Fleet on actions to be carried out in the Exclusion Zone for consideration at their Meeting on 11 April 1982
 - b. The single Service Departments to draft Rules of Engagement for use within the Exclusion Zone by surface ships and aircraft for their consideration at a Meeting early in the following week.
 - c. The Assistant Chief of the Defence Staff (Operations) to prepare a draft Planning Directive for Operation PARAQUET for consideration at their Meeting on 9 April 1982.
 - d. The Assistant Chief of Defence Staff (Policy) to prepare a Directive for an appreciation on Amphibious Operations against the Falkland Islands (Operation SUTTON) for their consideration at their Meeting on 9 April 1982.

ITEM 2. GIBRALTAR

5. The Assistant Chief of the Defence Staff (Policy) said he had prepared a draft paper on Gibraltar (4) which they had commissioned (5).

- 6. In discussion it was agreed that:
 - a. Orders were to be issued for B Company 1 Staffords to return to Gibraltar by 12 April 1982.
 - b. TA training, already planned, should continue in Gibraltar.
 - c. Orders were to be issued for the Guard ship to be stationed at Gibraltar.
 - d. Two Sea King helicopters of 824 Squadron were authorised to be retained in Gibraltar for the present.
 - e. To avoid increasing tension with Spain, movement of forces to Gibraltar should be presented as routine deployments.
 - f. The Air Force Department would re-examine the reforming of 291 SU RAF and its despatch to Gibraltar. An early report would be submitted to their Committee.

ITEM 3. MEETINGS

7. The Chiefs of Staff agreed that the Committee would meet daily throughout the Easter period and that scheduled meetings would start at 10.00 am.
