The following directive sets out the broad operational tasks in  
order of precedence:

Falkland Islands to complete the effectiveness of  
the Exclusion Zone as soon as possible.
- c. Repossess South Georgia(OP PARAQUET). (Reference C)
- d. Repossess the Falkland Islands(OP SUTTON).
