COS 20TH MEETING/82 HELD ON THURSDAY 15 APRIL 1982 AT 5.00 pm

ITEM 1. RULES OF ENGAGEMENT FOR OPERATION PARAQUET

- 1. SIR TERENCE LEWIN said that they would wish to discuss the Rules of Engagement for Operation PARAQUET (1) which had been tabled for their consideration.
- 2. SIR HENRY LEACH said that these specific rules had been prepared in accordance with the machinery for authorising Rules of Engagement already submitted and approved (2). Their originality lay only in their selection from an already agreed catalogue.
- 3. In discussion, the following points were made:
 - a. To attack a merchant ship or civilian aircraft without warning constituted a criminal act under International Law.
 - b. Although an SSN could make the distinction between a nuclear and conventional submarine target with a high probability of accuracy, a surface ship would be less able to do so. This would be a particular problem if a nuclear submarine target was being operated at less than its full capability, so that the pattern of its activity was similar to that of a coventional boat. There was therefore a risk, albeit slight, that a Soviet nuclear submarine within the declared zone could be mistaken for an Argentine conventional submarine and attacked. Ministers should be aware of this possibility.
 - c. While there was a need to remain within International Law, and therefore a requirement for Rules of Engagement to be modified, there was also the possibility that restrictions might be imposed which would prejudice the success of the operation. Ministers should also be aware of the inevitable conflict posed by a requirement to commit warlike acts without a formal declaration of war.

- 4. SIR FRANK COOPER (Permanent Under Secretary of State) said that he could not be associated with any advice going forward from the Ministry of Defence which recommended contravention of International Law.
- 5. Summing up, SIR TERENCE LEWIN said that they would wish to invite the Assistant Chief of the Defence Staff (Operations), in conjunction with the Defence Secretariat, to prepare a paper which would take account of their discussion and which he would forward to the Secretary of State later that evening. The Committee agreed that clearance of the final paper could be agreed on their behalf by the Chief of the Defence Staff, the Chief of the Naval Staff, and the Permanent Under Secretary of State out of committee.

ITEM 2. OPERATION SUTTON - APPRECIATION

6. The Committee approved the revised draft appreciation (3) for Operation SUTTON which had been tabled for their consideration. SIR TERENCE LEWIN said that they would wish him to instruct the Assistant Chief of the Defence Staff (Policy) to draft Terms of Reference for a study of the implications of keeping the landing force ashore on Ascension Island for up to two months, and of maintaining an effective sea and air blockade of the Falkland Islands during that period.

ITEM 3. OPERATION SUTTON - PLANNING DIRECTIVE

7. The Committee approved the draft planning directive (5) to CINCFLEET as amended in their discussion. SIR TERENCE LEWIN said that they would wish to instruct their Secretary to forward the Directive to CINCFLEET.

ITEM 4. BELIZE

8. After a short discussion the Committee agreed that, in view of the latest JIC assessment (7), they were content to leave the forces in Belize at their present levels. The Commander's tour of duty had been extended by three months in view of the delay (8) in withdrawal until 21 September 1982. SIR TERENCE LEWIN said that they would wish to invite the Vice Chief of the Defence Staff (Personnel and Logistics), in conjunction with the Service Departments, to ensure that sufficient forces remained available to meet the requirements in the Joint Theatre Plan (9) for the reinforcement of the British Garrison.
