SECRET Private Secretary OPERATION PARAQUET The Secretary of State may wish to see the attached note by the Navy Department on Operation Paraquet, which Mr. Nott is likely to raise at OD(SA) this morning. The Chiefs of Staff discussed this paper this morning, Mr. Nott's presence, and agreed to recommend that the Paraquet group should cross the 200 mile zone (as declared by the Argentines) today, with the intention of going to a position well off shore, so that a reconnaissance party could be landed on 21 April if required. I was not asked to comment on this, and did not therefore report the Secretary of State's view that the group should enter the 200 mile zone as proposed. 3. The Chief of Naval Staff also argued, on the lines of the attached paper, that the submarine CONQUEROR should receive Phase B Rules of Engagement as soon as possible, including the adoption B of Rule 5 ("any submarine detected not classified nuclear may be presumed to be Argentinian and may be attacked"). The Chief of Naval Staff was particularly keen that this should be authorised on the grounds that an Argentine submarine might be in the area; present intelligence suggests that this is unlikely. But the Secretary of State will wish to consider this against the view which he expressed this morning that the sinking of an Argentine ship should be avoided if at all possible, so long as the Haig mission continues.

4. Mr. Nott asked the Chiefs of Staff whether there was any way of arranging a landing (for intelligence gathering purposes) before 20 April. He was told that this would not be possible, and that the reconnaissance party, which would be ready to be landed on 20 April, would in effect be engaged initially in intelligence gathering.


# (Note by the Navy Department)

### A. Decision to Proceed

- 1. The Paraquet surface forces have made up some of the time lost in heavy weather and may now enter the South Georgia 200 nm exclusion zone declared by Argentina by p.m. 20 April. They could be in a position to start landing operations a.m. 21 April.
- 2. If it is desired to delay the execution of Paraquet the CinCFLEET should be informed today so that the Task Group can be held off in a suitable position, and outside the exclusion zone if the CinC prefers.

### B. Rules of Engagement

- 3. The OD (SA) has authorised that the phase B Rules of Engagement should come into force when Paraquet forces enter the area within 200 nm of South Georgia, subject to no ministerial decision to rescind this authority being made on 19 April.
- -4. The submarine CONQUEROR is already on patrol in the exclusion zone. It is possible, but there is no evidence to support this, that the Argentine 'Guppy' submarine SANTA FE could be in the area of South Georgia. In view of what is known of Argentine Rules of Engagement it is important that CONQUEROR receives her phase B rules of engagement as soon as possible.
- 5. The need for the surface ships to have phase B rules will become pressing by noon 20 April. Therefore, subject to no "rescinding instruction" being recived it is recommended that phase B rules be authorised for all Paraquet units within 200 nm of South Georgia from 1912002.



- 1. There are three sets of instructions which need to be agreed for issue to ships involved in Operation Paraquet. These cover:
  - a. Transit towards South Georgia on the high seas outside any declared Zone:
  - Transit within the declared Argentinian "Defence Zone" of 200 nautical miles around South Georgia:
  - c. Execution of Operation Paraquet within this Zone.
- 2. The Rules of Engagement to cover these three phases involve the following:
  - a. Transit towards South Georgia

Overriding aim is to avoid provocation but respond to aggression with firmness.

i. Surface Vessels

Minimum force to be used in response to any clear intent to engage. All units may assist in defence of any unit which is attacked. Maritime International Law is not to be broken unless necessary in order to achieve aim.

ii. SSNs

Surveillance to be covert, evading if detected. Engagement of enemy only if attacked first.

Transit within Argentinian "Defence Zone"

Aim is to show sufficient force to dissuade Argentinian units from enforcing their "Defence Zone".

i. Surface Vessels

To achieve transit, take any necessary action against positively identified Argentinian ships. In the case of merchant ships this would in the first instance be to warn off. You may attack any submarines which demonstrate hostile intent. Instructions on mutual defence and Maritime International Law as at 2 a. i. above.

### ii. SSNs

Any conventional submarine detected may be presumed to be Argentinian and may be attacked. All Argentinian warships and naval auxiliaries positively identified may be attacked.

### c. Execution of Operation

Aim is to repossess South Georgia.

### i. Surface Vessels

Any action necessary to achieve aim may be taken against ships and aircraft positively identified as Argentinian. You may attack any submarine which demonstrates hostile intent.

### ii. SSNs

As at 2 b. ii. above.

### c. Execution of Operation
