PREAMBLE: WE HAVE DILUTED STRENGTH OF REFERENCE TO UNGA RESOLUTIONS;

OPERATIVE PARA 1 (NUMBERING CORRESPONDS TO LONDON VERSION):
NO CHANGE. DRAFT DEFINITION OF "SURROUNDING AREAS" IN
REVISED PARA PREPARED.

OPERATIVE PARA 2:

- WE HAVE DELETED DESCRIPTION OF RESULT OF PARA AS
"DEMILITARIZATION";
- THE SIDE LETTER ON RETURN OF FORCES TO NORMAL OPERATING
AREAS HAS BEEN CONDENSED AND FOLDED INTO THIS PARA, BUT
WITH NO SUBSTANTIVE CHANGE (REFERENCE TO NON-USE OF
FORCE OR THREAT OF FORCE DROPPED, BUT CONTAINED IN
UNSC RESOLUTION PREAMBLE, AND OF COURSE IN UN CHARTER);

OPERATIVE PARA 3:

- WE NOW HAVE A SPECIAL COMMISSION VICE GROUP;
- AS DRAFTED, DUTIES OF VERIFICATION INCLUDE SIDE-LETTER
AGREEMENT ON RETURN OF FORCES, NOT IN BA DRAFT.

OPERATIVE PARA 4:

- WE HAVE ADDED NOTION OF SUBMISSION AND EXPEDITIOUS
RATIFICATION OF LOCAL GOVERNMENT ACTS;
- WE ARE REFERRING TO PURPOSES OF THE AGREEMENT VICE
ITS SPIRIT;
- WE HAVE INCLUDED ENLARGEMENT OF LOCAL COUNCILS TO
PROVIDE REPRESENTATION OF ARGENTINE POPULATION RESIDENT
ON ISLANDS;
- WE HAVE DROPPED REFERENCE TO POWERS OF SPECIAL COMMISSION
BEING EQUIVALENT TO THOSE OF A GOVERNOR;
- WE HAVE ADDED PROVISION ON DISPLAY OF FLAGS AT COMMISSION
HQ; NUMBER OF COMMISSIONERS HAS BEEN MOVED TO OP. PARA 3.

OPERATIVE PARA 5:

- INTERIM NATURE OF COMMITMENTS REGARDING LINKS BETWEEN
MAINLAND AND ISLANDS REPLACED BY STRONGER INTRODUCTORY
WORD "HENCEFORTH"; THIS CREATES AMBIGUITY WHETHER THIS
COMMITMENT SURVIVES DECEMBER 31 DATE, IF THIS IS
CONCLUDED AS AN INTERNATIONAL AGREEMENT;

OPERATIVE PARA 6:

- WE HAVE CLARIFIED THAT ECONOMIC SANCTIONS ARE TO BE LIFTED IN SAME TWO-WEEK PERIOD FORCES ARE TO BE WITHDRAWN;
- WE REFER TO TERMINATION OF SANCTIONS, VICE NULLIFICATION OF THEM;

OPERATIVE PARA 7:

- WE HAVE ADDED REFERENCE TO PURPOSES AND PRINCIPLES OF UN CHARTER;
- WE DESCRIBE PERIOD PRIOR TO DECEMBER 31 AS INTERIM VICE TRANSITION PERIOD.
