MY TELEGRAM NO. 161: EC/ARGENTINA

1. ATTOLICO, HAVING CONSULTED BUCCI, HAS TELEPHONED TO SAY THAT, ON CONTROL OF IMPORTS, HE BELIEVES THE ITALIANS SHOULD BE ABLE TO MEET OUR TWO POINTS PROVIDED OTHER PARTNERS AGREE.
2. ON CREDITS, HE HAS NOT YET BEEN ABLE TO CONSULT MINISTERS BUT WILL HOPE TO HAVE DONE SO BY TOMORROW'S COREPER. MEANWHILE, WE CAN TAKE IT THAT THE ITALIANS WILL !!STOP ANYTHING SIGNIFICANT!! ON COMMERCIAL GROUNDS. ATTOLICO EXPRESSED DOUBT AS TO WHETHER A COMMUNITY DECISION WAS NEEDED. WE HAVE TOLD HIM THAT, FOLLOWING FURTHER DISCUSSION IN BRUSSELS, NATIONAL ACTION COULD BE APPROPRIATE (CF. UKREP BRUSSELS TELEGRAM NO. 1465): THE IMPORTANT THING WAS THAT ALL PARTNERS SHOULD DO THE SAME.
