THE MAN AND ANOT TO ALL I. PALKLAND ISLANDS AT THE HIM

1. I SAW THE PRESIDENT OF THE SECURITY COUNCIL THIS MORNING (14 APRIL) AND SPOKE ON THE LINES OF PARAGRAPHS 1 AND 2 OF MY TELEGRAM UNDER REPERENCE. KAMANDA WAS COOPERATIVE. HE SAID THAT THERE WAS NUCH CONCERN IN NEW YORK ABOUT THE CRISIS. BUT HE TOOK THE POINT THAT IT WOULD BE WRONG FOR THE COUNCIL TO INVOLVE ISSEEF WHILE THE HAIG MISSION WAS UNDERWAY AND PROMISED THAT AS LONG AS THE PARTIES WISHED HAIG TO CONTINUE HIS EFFORTS THE SECURITY COUNCIL WOULD NOT IMPEDE HIS EFFORTS IN ANY WAY.

2. SHORTLY AFTERNARDS, MY PANAMANTAN COLLEAGUE GAVE HIM AN 8-PAGE LETTER IN SPANISH WHICH CONCLUDED WITH A REQUEST THAT KAMANDA LONVELE URGENT INFORMAL CONSULTATIONS SO THAT THE GOUNG IL COULD TAKE AFFRORMATE MEASURES FOR A PEACEFUL SOLUTION OF THE CRIS IS, THE LETTER SETS OUT THE ARGENTINE CASE AT TEDIOUS LENGTH AND IN OFFENSIVE TERMS. WE WILL FACSIMILE THE TRANSLATION AS SOON AS IT IS AVAILABLE. THE MAIN THEMES ARE:

(A) APPLAUSE FOR THE BLOODLESS WAY IN WHICH THE ARGENTINES RECOVERED THEIR TERRITORY:

(B) DENUNCIATION OF OUR NAVAL TASK FORCE AND OF THE MEZ:

(C) INVOCATION OF THE AMERICAN COLLECTIVE SECURITY SYSTEM AND THE MONROE DOCTRINE, AND CRITICISM OF THE US FOR MAKING ITS BASE ON ASCENSION AVAILABLE TO US.

(0) DENUNCIATION OF THE ECONOMIC SANCTIONS IMPOSED BY THE UK, THE EUROPEAN COMMUNITY AND OTHER COUNTRIES, WHICH ARE DESCRIBED AS ECONOMIC AGGRESSION AND A VIOLATION OF THE UR
