^{2.} Introduction. In the absence of an Agendum (which probably will not now appear until circa 190900A) I can only guess that the primary topic for discussion is the question of ROE for all maritime forces (other than Op PARAQUET forces). A secondary topic may well be a further review of the Major Decisions Required.

- 3. Action Before OD(SA)(82) Meeting. Before the meeting you may wish to refresh your memory on PS/FCS letter "What if Haig talks fail" at FLAG I, Pym's signal to Haig at FLAG J, and Haig's reply yesterday evening (which you have seen in the signals folder this morning) at FLAG K. Please see also the exchange of correspondence enclosed in the separate folder.
 - 4. ROE Sea Transit on High Seas. Following OD(SA)(82) Meeting on 16 Apr PS/S of S sought agreement (by lunchtime 19 Apr) for the issue of "high seas ROE" at FLAG D. The following day at FLAG E S of S raised the question of an announcement about the response to be expected from British Forces on the High Seas. Now (given COS approval)COS MISC 134/742/1 at FLAG F is presented for OD(SA) approval as a matter of urgency.
 - on to the Major Decisions Required. OD(SA) discussion might then move on to the Major Decisions Required. In this context you will recall PUS's note which was discussed yesterday evening (FLAG G) and the latest issue of Major Decisions Required at FLAG H.
