1. YOU WILL BE RECEIVING SEPARATELY A COPY OF OUR TELEGRAMS TO WASHINGTON ASKING HM AMBASSADOR TO GIVE MR HAIG THE COUNTER PROPOSALS TO THE BUENOS AIRES TEXT (FCO TELNO 765 TO WASHINGTON) WHICH THE PRIME MINISTER AND I CONSIDER ESSENTIAL.
2. NOT INCLUDED IN THESE AMENDMENTS, BUT UNDER CONSIDERATION STRICTLY AMONG OURSELVES FOR POSSIBLE FUTURE USE, IS A NEW PARAGRAPH, TO PRECEDE PARAGRAPH 8 OF THE ARGENTINE TEXT, AS FOLLOWS:

BEGINS: (A) THE TWO GOVERNMENTS AGREE TO INVITE THE UN SECURITY COUNCIL TO ARRANGE FOR THE STATIONING IN THE FALKLAND ISLANDS (ISLAS MALVINAS), FOR THE DURATION OF THE INTERIM PERIOD REFERRED TO IN PARAGRAPH 8(A) OF THIS AGREEMENT, OF A SQUARE BRACKETS PEACE-KEEPING FORCE SQUARE BRACKETS, SQUARE BRACKETS OBSERVER FORCE SQUARE BRACKET OF APPROPRIATE SIZE AND COMPOSITION. THE FUNCTION OF THE FORCE SHALL BE TO OBSERVE COMPLIANCE BY THE TWO GOVERNMENTS WITH THEIR OBLIGATIONS UNDER PARAGRAPH 3 OF THIS AGREEMENT AND TO REPORT REGULARLY THEREON, THROUGH THE SECRETARY GENERAL OF THE UN, TO THE SECURITY COUNCIL.

(B) THE UNITED STATES GOVERNMENT HAS INDICATED THAT IT WILL SUPPORT SUCH A REQUEST TO THE SECURITY COUNCIL.
