YOUR TELNO 282: FALKLAND ISLANDS: YOUR VISIT TO WASHINGTON

- 1. I SEE NO SERIOUS DIFFICULTY IN THE PROPOSAL IN PARAGRAPH 2 OF YOUR TELEGRAM UNDER REFERENCE. THE FORCE WOULD BE AN OBSERVER FORCE, CN THE LINES OF UNTSO, AND THUS EASIER TO GET THROUGH THE COUNCIL THAN A PEACEKEPING FORCE SUCH AS UNIFIL. (THE SECRETARY—GENERAL HAS ALREADY ENVISAGED SUCH AN ARRANGEMENT IN THE PAPER TRANSMITTED IN MY TELNO 501). THE RUSSIANS WOULD PROBABLY TRY TO SCORE POINTS OFF THE AMERICANS AND OURSELVES BY GRIZZLING ABOUT THE FACT THAT THE WHOLE AGREEMENT HAD BEEN NEGOTIATED OUTSIDE THE UN FRAMEWORK. THEY MIGHT MAKE DIFFICULTIES OVER THE FINANCIAL ARRANGEMENTS.
 BUT THE REST OF THE COUNCIL WOULD BE DELIGHTED TO HAVE ANY UN INVOLVEMENT, AND THE RUSSIANS WOULD THEREFORE BE UNLIKELY TO VETO THE RESCLUTION SETTING UP THE FORCE, SINCE THERE WOULD BE NOBODY TO PLEASE BY DOING SO. WITH THE UN SECRETARIAT'S LONG EXPERIENCE, THERE WOULD BE NO DIFFICULTY IN ACTUALLY GETTING A FORCE TO THE AREA OUICKLY.
 - 2. AS REGARDS THE MECHANICS, RGCA (ARGENTINA) AND I WOULD HAVE TO ACT IN CONCERT. I WOULD NOT ANTICIPATE DIFFICULTIES OVER THE DETAILED ARRANGEMENTS.
 - 3. THE MAIN PROBLEM WOULD BE THE TIMING OF OUR APPROACH TO THE COUNCIL. IT WOULD BE A FATAL MISTAKE TO DO SO BEFORE WE AND THE ARGENTINES HAD SIGNED THE AGREEMENT. TO GO TO THE COUNCIL IN ADVANCE OF SIGNATURE WOULD OPEN THE WAY TO ENDLESS TROUBLE MAKING, BOTH WELL INTENTIONED AND MALEVOLETT. I BELIEVE THEREFORE THAT THE BEST COURSE WOULD BE FOR ROCA AND MYSELF TO BE INSTRUCTED TO APPROACH THE PRESIDENT OF THE COUNCIL IMMEDIATELY AFTER THE AGREEMENT WAS SIGNED,.
