- 3. Prior to the Meeting you should read the folder of overnight signals traffic and scan both the Supplementary INTSUM 251950Z and the latest INTSUM No 43 260600Z. I believe that you are thoroughly familiar with all other relevant papers.

### ACTION AT THE MEETING

- 4. Item 1 Selective Call Out of Reservists. The Memorandum by SofS is at FLAG E was produced by DS5/DGNMT and presumably it has the blessing of CNS. As I understand the problem SofS is seeking colleagues' approval as a precautionary measure at this stage. If the need to Reservists should arise (if further ships are requisitioned for service at short notice) then SofS will need to act quickly to fill the gaps. Prior permission now to call out Reservists will enable SofS to act in timely fashion should the need arise.
- 5. Item 2 Total Exclusion Zone. The paper for discussion (OD(SA)(82)24 dated 23 Apr 82) is at FLAG F. In considering this paper you will wish to take into account the two suggestions made by DS11 at FLAGs G and H respectively. The revised draft TEZ Public Statement is at FLAG I immediately after the original draft.

- approval for Special Forces Operations. In seeking overall approval for Special Forces operations and in any discussion of how and when such forces may be employed you will wish to draw upon FLAGs J and K against the background of CINCFLEET's Outline Plan for Op SUTTON at FLAG L. In the light of FLAG K Para 4 I suggest that you should seek OD(SA) approval for SF operations in principle leaving the details to be arranged by the CTF/CTG as appropriate.
- 7. Item 4 Commitment of Amphibious Group. In discussing the commitment of the Amphibious Group from Ascension Island you may wish to refresh your memory with FLAG M. In this context ACDS(Pol)'s paper on 'Strategic Options' (FLAG N) is relevant and so are the COS views at FLAG O TAB 1. If the discussion widens into a broad consideration of Op SUTTON, the position of the Falkland Islanders in a blockade, an Argentine withdrawal etc then FLAGs P, Q and R may be useful.
- 8. Item 5 Draft Agreement. The discussion paper is at FLAG S. It is not known what particular aspect of the draft Agreement is to be tabled for discussion, but in addition to FLAG S you may care to refer to FLAGs T and U.
- 9. Item 6 Any Other Business

a. Amendment to SSN ROE. It might be opportune to prompt SofS to raise the question of amended ROE for the SSN in the MEZ to include 'Landing Ships' as fair game; your FLAG V refers.

2. All military and security forces ether than local police shall be withdrawn within a short period of time, but not later than two weeks from the date of this agreement, from three areas defined by circles of 150 nautical miles radius from the following co-ordinate points:

c. Lat. 57° 40° South Long. 26° 30° West [South Sandwich

### (HAIG 19 APRIL)

On the basis of United Matienal Security Council Resolution 502, and the will of the Argentine Republic and of the United Kingdom to resolve the controversy which has arisen between them renouncing the use of force, both governments agree on the following steps which form an integrated whole:

- 1. Effective on the signature of this agreement by both governments, there shall be an immediate cessation of hostilities.
- 2. Beginning at 0000 hours on the day after the day on which this agreement is signed, the Republic of Argentina and the United Kingdom shall not introduce nor deploy forces into the zones (hereinafter, "zones") defined by circles of 150 nantical miles radius from the following co-ordinate points (hereinafter, co-ordinate points"):

- 2.2 Within 24 hours of the date of this agreement Argentina and the United Kingdom will commence the withdrawal of their forces in accordance with the following details.
- 2.2.1. Within seven days from the date of this agreement, Argentina shall have withdrawn one half of its military and security forces present in the zones on the date of this agreement, including related equipment and armaments. Within the same time period, the United Kingdom will have completed the withdrawal of all of its forces from the zones and the United Kingdom Naval Task Force will stand off at a distance of at least 1750 nautical miles from any of the co-ordinate points.

On the basis of United National Security Council Resolution 502, and the will of the Argentine Republic and of the United Kingdom to resolve the controversy which has arisen between them renouncing the use of force, both governments agree on the following steps which form an integrated whole:

- 1. Effective on the signature of this agreement by both governments, there shall be an immediate cessation of hostilities.
- 2. Beginning at 0000 hours on the day on which this agreement is signed, the Republic of Argentina and the United Kingdom shall not introduce nor deploy forces into the zones (hereinafter, "zones") defined by circles of 150 nautical miles radius from the following co-ordinate points (hereinafter, "co-ordinate points"):

- 2.1. Within 24 hours of the date of this agreement, the United Kingdom will suspend enforcement of its zone of exclusion and Argentina will suspend operations in the same area.
- 2.2 Within 24 hours of the date of this agreement, Argentina and the United Kingdom will commence the withdrawal of their forces in accordance with the following details.
- 2.2.1. Within seven days from the date of this agreement, Argentina and the United Kingdom shall have withdrawn one-half of their military and security forces present in the zones on the date of this agreement, including related equipment and armaments. Within the same time period, the United Kingdom naval task force will stand off at a distance equivalent to 7 days' sailing time (at 12 knots) from any of the co-ordinate points, and Argentine forces that have been withdrawn shall be placed in a condition such that they could not be reinserted with their equipment and armment in less than 7 days.

2.2.2. Vithin 15 days from the date of this agreement. Argentina shall remove all of its remaining forces, equipment and armaments from the zones. Within the same time period, units of the United Kingdom Naval Task Force and submarines shall redeploy to their usual operating bases or areas.

2.2.2. Within 15 days from the date of this agreement, Argentina shall remove all of its remaining forces and redeploy them to their usual operating areas or normal duties. Within the same period the United Kingdom naval task force and submarines shall redeploy to their usual operating areas or normal duties.

2.3. The United States, depending on its acceptance, shall verify compliance with provisions 2 through 2.2.2.

  - 9.2 Issues relating to the development of the resources of the islands, including opportunities for joint co-operation and the role of the Falkland Islands Company; and
  - 9.3 Such other matters as the two signatories may request, including possible arrangements for compensation of islanders, or matters on which the Authority may wish to comment in light of its experience in discharging its responsibilities under this Agreement.
  - 9.4 The signatories have agreed on the procedure in sub-paragraph 9.1 without prejudice to their respective positions on the legal weight to be accorded such opinion in reaching a definitive settlement.
- 10. Should the signatories nonetheless be unable to conclude the negotiations by December 31, 1982, the United States has indicated that, on the request of both signatories, it would be prepared at such time to seek to resolve the dispute within six months of the date of the request by making specific proposals for a settlement and by directly conducting negotiations between the signatories on the basis of procedures that it shall formulate. The two signatories agree to respond within one month to any formal proposals or recommendations submitted to them by the United States.
- 11. This Agreement shall enter into force on the date of signature.
