ARAB/ISRAEL: KING HUSSEIN'S WIEWS

SUMMARY

1. KING HUSSEIN INTENDS TO TAKE A FIRM LINE WITH ARAFAT ON 28 OCTOBER, HAVING OBTAINED SUPPORT FROM EGYPT AND IRAQ. THE KING HIS HURT BY THE US ADMINISTRATION'S DECISION ON ARMS SALES, BUT GUARDED ABOUT THE PERES PROPOSALS. HE IS OPTIMISTIC ABOUT CONTACTS WITH SYRIA.

DETAIL

- 2. COUNSELLOR SAW KHANG HUSSEIN ON 27 OCTOBER. THE KANG, WHO HAD SEEN PRESIDENT MUBARAK, UNDER SECRETARY RACHARD MURPHY AND PRESIDENT SADDAM HUSSEIN IN THE PRECEDING WEEK AND WAS ABOUT TO SEE YASSER ARAFAT, GAVE THE FOLLOWING OUTLINE OF HIS CURRENT THINKING.
- 3. THE KING SAID THAT HE HAD BEEN APPALLED BY THE LARNACA KILLINGS, THE IISRAELIE RAID ON TUNIS AND THE HIJACKING OF THE ACHILLE LAURO. AT HIS MEETING WITH ARAFAT ON 28 OCTOBER HE INTENDED TO TAKE A FIRM LINE. HE INTENDED TO SAY THAT THE 11 FEBRUARY AGREEMENT WAS AND REMAINED THE FOUNDATION STONE OF JORDANIAN POLICY, BUT THAT IF ARAFAT WISHED TO BE TAKEN SERIOUSLY AS A NEGOTIATING PARTNER HE WOULD HAVE TO PROVIDE SOLID ASSURANCES ON THE FOLLOWING TWO POINTS:
 - A. THAT HE COULD AND WOULD EXERCISE FIRM CONTROL OVER ALL MEMBERS OF THE PLO, AND THAT

B. ALL TERRORIST ACTS SUCH AS THE LARNACA KILLINGS AND THE ACHILLE LAURO HIJACKING WOULD CEASE FORTHWITH.

WHEN ASKED WHAT HE WOULD DO OF ARAFAT EITHER REFUSED TO GIVE SUCH ASSURANCES, OR OF HE JUDGED THAT ARAFAT WAS INCAPABLE OF HONOURING THEM, THE KING SAID THAT HE WOULD PUBLICUSE THE EXCHANGE AND LET THE PALESTIMIAN PEOPLE FORM THEIR OWN JUDGE ENT ABOUT THEIR LEADERSHIP. HE SAID THAT, IN ANY CASE, HE INTENDED IN HIS SPEECH AT THE OPENING OF PARLIAMENT ON 2 NOVEMBER TO MAKE NO REFERENCE AT ALL TO THE PLO AND HIS AUDIENCE COULD MAKE OF THAT WHAT THEY LIKED. HE SAID THAT HE HAD RECEIVED BACKING FOR HIS PROPOSED LINE WITH ARAFAT FROM THE PRESIDENTS OF EGYPT AND ORAG.

4. THE KING SAID THAT HIS MEETINGS WITH RICHARD MURPHY HAD BEE
CONSTRUCTIVE. MURPHY HAD STRESSED THE HELPFUL ASPECTS OF PERES'
SPEECH TO THE UNITED NATIONS, AND THE KING HAD AGREED THAT CERTAIN
ASPECTS OF THE SPEECH WERE INDEED POSITIVE. THE KING WOULD NOT
BE FURTHER DRAWN ON PERES' PROPOSALS, ONLY REPEATING THAT WHILE
MUCH WOULD DEPEND OF HIS TALKS WITH ARAFAT, THE FEBRUARY 11
AGREEMENT REMAINED THE BASIS OF JORDANIAN POLICY.

5. THE KING WENT ON TO SAY THAT MURPHY'S VILSHT HAD BEEN SPORLT BY THE US ADMINISTRATION'S VOLTE FACE THE FOLLOWING DAY ON ARMS FOR JORDAN. THE KING WAS PARTICULARLY UPSET THAT MURPHY HAD MADE NO MENTION OF THE POSSIBILITY AND THAT THE AMERICANS HAD NOT HAD THE COMMON COURTESY TO WARN HIM IN ADVANCE OF THE DECISION. ALL HE HAD RECEIVED WAS A LETTER FROM PRESIDENT REAGAN AFTER THE EVENT. THE KING SAID THAT THIS WAS THE END OF THE LINE AS FAR AS ARMS SUPPLIES FROM THE US WERE CONCERNED. HE HAD PUT A GREAT DEAL OF PERSONAL EFFORT INTO TALKING TO SENATORS AND CONGRESSMEN AND HE COULD NO LONGER AFFORD TO DAMAGE HIS CREDIBILITY IN THIS WAY. JORDAN WOULD HAVE TO LOOK ELSEWHERE FOR ARMS SUPPLIES.

6. TURNING TO SYRIA THE KING SAID THAT HE HAD BEEN MUCH ENCOURAGED BY THE PROGRESS MADE AT THE SECOND MEETING BETWEEN THE JORDANIAN AND SYRIAN PRIME MINISTERS IN RIYADH. AFTER THE MEETING PRESIDENT ADA HAD TELEPHONED HIM AND THEY HAD HAD A FRINDLY AND POSITVE CONVERSATION. AT THE NEXT MEETING OF THE TWO PRIME MINISTERS IN DAMASCUS HE HOPED PREPARATIONS WOULD BEGIUN FOR A MEETING BETWEEN HIMSELF AND PRESIDENT ASAD. WHEN SPEDDING COMMENTED THAT THE COMMUNIQUE IN RIYADH APPEARED TO FAVOUR THE SYRIAN POSITION, THE KING AGREED BUT SAID THAT THERE HAD BEEN REAL MOVEMENT ON THE SYRHAN SIDE, PARTICULARLY OVER THE QUESTION OF AN INTERNATIONAL CONFERENCE ON WHICH THE SYRIAN POSITION WAS NOW MUCH CLOSER TO THE JORDANIAN. THE MEETING HAD ALSO SERVED TO CLEAR AWAY SOME SYRIAN MISUNDER-STANDINGS ABOUT WHAT THEY HAD SEEN AS CONTRADICTIONS BETWEEN THE FEZ SUMMIT RESOLUTIONS AND THE FEBRUARY 11 AGREEMENT. HE BELIEVED IT WAS POSSIBLE TO DRAW SYRIA INTO THE ARAB CONSENSUS.

7. FINALLY ON EGYPT KING HUSSEIN SAID THAT HE WAS WORRIED ABOUT THE EFFECT OF THE ACHILLE LAURO AFFAIR ON MUBARAK'S POSITION.

MUBARAK, HE SAID, HAD MISSED A NUMBER OF OPPORTUNITIES OVER THE YEARS TO DEMONSTRATE HIS LEADERSHIP AND IN CONSEQUENCE THE INTERNAL DISTURBANCES IN THE AFTERMATH OF THE AFFAIR WERE DOING DISPROPORTHONATE DAMAGE TO THE PRESIDENT'S STANDING.

THE KING SAID THAT INSTABILITY IN EGYPT WAS VERY WORRYING TO JORDAN. ANY REPLACEMENT FOR MUBARAK, FROM RIGHT OR LEFT, WOULD BE A BLOW TO HOPES OF PEACE. JORDAN WAS THEREFORE DOING EVERYTHING POSSIBLE TO BOLSTER JORDANIAN/EGYPTHOAN RELATIONS IN AN EFFORT TO SHORE UP MUBARAK.
