## SUMMARY

1. IT IS NOW REASONABLY CLEAR THAT THE CORRECT INTERPRETATION
OF RECENT JORDANIAN MOVES IS THAT KING HUSSEIN HAS DELIBERATELY
EMBARKED ON A POLICY OF TRYING TO BRING SYRIA AND THE SOVIET
UNION INTO THE PEACE PROCESS BUT THAT HIS PRIME MINISTER WENT
FURTHER THAN ANYONE ELSE INTENDED IN DAMASCUS.

## DETAIL

- 2. THE EVIDENCE IS NOW OVERWHEPMING THAT RIFAL WENT TOO FAR:

  (A) I HAVE ALREADY REPORTED (PARA 8 OF MY TUR AND PARA 5 OF MY TELNO 608) THE THINLY VIELED DOUBTS OF THE CROWN PRINCE AND MINISTER OF COURT ABOUT THE MANNER OF THE RAPPRICHEMENT WITH SYRIA AND RIFAL'S INITIAL UNCONVINCING DEFENCE OF THE COMMUNIQUE.
- (B) THE HEAD OF THEY ROYAL DIWAN, WHO ACCOMPANIED RIFAL, HAS LET IT BE KNOWN BOTH THAT HIS ADVICE TO RIFAL IN DAMASCUS WAS NOT TO AGREE TO ISSUE ANY COMMUNIQUE AND THAT HE TOLD THE KING ON HIS RETURN THAT THAT HAD BEEN HIS ADVICE.
- (C) I ASKED THE COMMANDER-IN-CHIEF ON 19 NOVEMBER HOW I WAS TO INTERPRET THE DAMASCUS RAZPRICHEMENTOM HE REPLIED THAT THE KING WAS TRYING TO BRING SYRIA INTO THE PEACE PROCESS, WHICH WAS PROBABLY WISE, 'BUT SOME OF US ARE KEENER ON IT THAN OTHERS''.
- 3. THE US AMBASSADOR TELLS ME THAT BEFORE RIFAI LEFT WITH
  THE KING ON HIS CURRENT MIDDLE EAST TOUR HE AND CLUVERIUS HAD
  A TWO-HOUR MEETING WITH HIM. RIFAI WAS CHASTENED. THE MOST
  IMPORTANT POINT IS THAT WHILE ON 14 NOVEMBER (MY TUR) RIFAI HAD
  PLACED A QUITE NEW EMPHASIS ON THE NEED TO HAVE SYRIA AT AN
  INTERNATIONAL CONFERENCE, ON 16 NOVEMBER HE MAINTAINED THAT
  THERE HAD BEEN NO CHANGE ON JORDAN'S PREVIOUS POSITION, NAMELY
  THAT IT WAS NECESSARY THAT AN INVITATION SHOULD BE EXTENDED TO
  SYRIA, COUPLED WITH A REASONABLE OFFER FROM ISRAEL TO NEGOTIATE
  ABOUT THE GOLAN (SEMI COLON) BUT THAT IF THE INVITATION WERE
  DECLINED, THEN THE PROCESS WOULD GO AHEAD WITHOUT SYRIA. BOEKER
  CONCLUDES, I THINK CORRECTLY, THAT THE KING HAD MEANWHILE
  PULLED RIFAI BACK ON COURSE.
- 4. IN THE LIGHT OF THIS EVIDENCE I NOW BELIEVE THAT HUSSEIN, IN THE WAKE OF THE US ARMS DECISION AND RECENT PLO BEHAVIOUR, REASSESSED HIS POLICY (SEMI COLON) DECIDED THAT THE TIME HAD

COME TO TRY TO BRING SYRIA AND THE SOVIET UNION IMTO THE PEACE PROCESS AND THAT THAT WAS EVEN MORE NECESSARY GIVEN FRESH DOUBTS, ABOUT THE DEPTH OF THE US COMMITMENT TO THE PROCESS (SEMI COLON) RECOGNISED THE VALUE OF THE SYRIAN FACTOR IN PUTTING PRESSURE ON ARAFAT (SEMI COLON) RECOGNISED TOO THAT BETTER RELATIONS WITH SYRIA MIGHT HELP TO OBTAIN MORE SAUDI FINANCIAL AID (SEMI COLON) BUT STILL AIMS TO GET THE PEACE PROCESS BACK ON THE RAILS. THE TASK IS NOW MUCH MORE COMPLEX PARTICULARLY AS HE WOULD ALMOST CERTAINLY HAVE TO MAKE CONCESSIONS ON THE STRUCTURE OF A CONFERENCE TO HAVE ANY HOPE OF GETTING SYRIA AND THE SOVIET UNION ON BOARD. BUT IT WAS ALWAYS IMPLICIT IN HIS INITIATIVE THAT AN APPROACH WOULD HAVE TO BE MADE AT SOME TIME TO SYRIA AND THE SOVIET UNION. THE BEST EVIDENCE THAT THIS IS THE RIGHT WAY TO INTERPRET THE KING'S CURRENT POLICY IS IN FACT THE KING'S OWN DESCRIPTION OF IT IN MY TELNO 602. IT WAS RIFAL'S PERFORMANCE IN DAMASCUS THAT MADE ME INITIALLY RELUCTANT TO TAKE HUSSEIN'S ACCOUNT AT FACE VALUE.

5. THE KING NOW HAS AN INTERNAL POLITICAL NEED, ASDWLL -' -,
EXTERNAL ONE, TO CLARIFY HIS POLICY. I HAVE NEVER KNOWN
HIS ADVISERS IN SUCH DISARRAY AND THE BEWQCNZUENT GOES WELL
BEYOND THE CHARMED CIRCLE. BUT HE MAY NOT BE ABLE TO DO THIS
UNTIL ARAFAT BRINGS REPLIES TO HIS EARLIER QUESTIONS (WHICH
AMAFAT IS EXPECTED TO DO FOLLOWING A PLO EXECUTIVE COMMITTEE
MEETING TO BE HELD SHOPLY IN BACHDAD, AND UNTIL HE HAS EXPLORED

MEETING TO BE HELD SHORTLY IN BAGHDAD) AND UNTIL HE HAS EXPLORED THE SYRIAN POSITION IN MORE DEPTH. THERE IS NOW TALK OF HUSSEIN GOING TO DAMASCUS IN EARLY DECEMBER.
