RABIN'S VIEWS ON THE PEACE PROCESS

SUMMARY

1. THE WASRAELIN MEMBESTER MOF DEFENCE SEES A STALEMATE IN THE PEACE PROCESS. QUILET CONTACTS WINTH JORDAN SHOULD CONTAINE WINTH A VINEW TO BUILDING UP THE KING'S POSITION IN THE OCCUPIED TERRINTORIES. ARABISATION OF DAILY LIFE WINTHIN THE PRESENT LEGAL AND SECURISTY FRAMEWORK THE SIMMEDILATE AND.

DETAIL

- WHEN IN TOOK SIR A URWINCK TO CALL ON RABBIN ON MAY 1 WE ASKED HIM HOW HE SAW THE PEACE PROCESS. RABBIN REPLIED THE KING HAD MADE A MAJOR MISCALCULATION IN HIS FEBRUARY SPEECH. HE HAD BUILT UP EXPECTATIONS IN THE TERRITORIES DURING HIS NEGOTIATIONS WITH ARAFAT IN THE PRECEDING YEAR SEMICUN AND THEN HAD DASHED THEM WITH HIS SPEECH WITHOUT OFFERING ANYTHING IN THEIR PLACE. HE HAD THEN SALD IN EFFECT TO THE WISRAELIAS THAT HE COULD NOT WORK WITH ARAFAT, SO PLEASE HELP ME. RABBIN SAND THE KING WAS TOO WEAK TO NEGOTIATE WITH INSRAEL ALONE SO THERE WAS NOW A STALEMATE. HE THOUGHT WISRAEL SHOULD KEEP UP QUIET CONTACTS WITH JORDAN BUT THERE WAS ALSO NEED FOR THURD PARTY ASSISTANCE (HE DID NOT ELABORATE).
- 3. HISRAEL WOULD TRY TO HELP BUILD UP SUPPORT FOR THE KING HIN THE TERRITORHES, BUT THUS WAS A LONG TERM PROPOSISTINON. EVEN BEFORE THE KING'S SPEECH THE HISRAELHS HAD REALHSED THE PLON ALLEGMANCE WAS DOMENANT, FOR WHATEVER REASON. AL-MASRIM'S ASSASSIMATION HAD NOT REALLY ALTERED THE POSITION.
- AT A RECENT CONFERENCE WHITH WASRAELM DEPARTMENTAL HEAD AND ARAB
 OFFICIALS FROM THE TERRITORNES INT HAD BEEN OBVIOUS THE LATTER DID
 NOT WANT POLITICAL RESPONSIBILITY OR MINVOLVEMENT EXCEPT ON THE
 WELL-KNOWN PLO TERMS OF TAKING OVER ANY PART OF THE PALESTMINIAN HOME—
 LAND FROM WHICH WASRAEL MIGHT UNMLATERALLY WITHDRAW. JORDAN AND
 EGYPT WERE NOT YET READY FOR ANY MAJOR POLITICAL CHANGE IN THE
 TERRITORNES. THE MOST THAT WAS POSSIBLE IN CURRENT POLITICAL
 CONDUCTIONS WAS GREATER ARABISATION OF THE ADMINISTRATION WITHIN
 THE EXISTING FRAMEWORK OF LAW AND SECURITY. THIS COULD GO WITH
 THE VARIOUS EDEAS FOR PRACTICAL IMPROVEMENTS IN THE LIFE OF THE
 WINHABIITANTS WHICH WERE CURRENTLY BEING CANVASSED.

TO THE EGYPTHAN WHEW. HIS MIDEAS ON FUTURE MOVES WATHEN THE TERRITORIES SEEM CONSISTENT WITH THE THINKING IN AMMAN AND CALRO. THEY ARE LIMITED IN SCOPE BUT MAY BE NEAR THE MARK THAN SOME OF THE BOLDER MIDEAS THAT HAVE BEEN FLOATED BE.G. GAZA FARST). HE IS AFTER ALL THE MANNESTER WATH EXECUTIVE RESPONSIBILITY FOR THE TERRITORIES. MR PERES AS NOT LIKELY TO GO BEYOND WHAT RABIN THANKS PRACTICABLY, PARTICULARLY GIVEN COALITION CONSTRAINTS.
