## FOLLOW-UP OF MMC REPORTS ON NATIONALISED INDUSTRIES

Despite reservations expressed by George and Patrick on some aspects and some qualifications on points of detail, there appears to be a fair measure of support for the proposals in my letter. It should be possible to apply the suggested procedures flexibly to overcome any difficulties which might arise in particular cases.

I agree that we should now take matters forward with the NICG and MMC as you propose. Our officials are already in touch about this and will bring in other Departments at a later stage. I hope too that you will be able to speak to the Chairman of the Liaison Committee to encourage the Select Committees to take a closer interest in action on MMC reports and that colleagues will similarly approach the Chairmen of the Select Committees with which they deal.

FOLLOW-UP OF MCC COMPETITION ACT REPORTS ON NATIONALISED INDUSTRIES

The Chancellor will wish to know that my Secretary of State has now spoken with the Chairman of the Liaison Committee, Mr Terence Higgins, and suggested to him that the Select Committee should take a closer interest in MMC reports and subsequent follow-up.

- 2. My Secretary of State explained that the MMC has now completed a substantial number of efficiency audits of nationalised industries and other bodies and the reports contain constructive recommendations for improving performance; that we are continuously seeking to improve follow-up in the light of experience; that since Select Committees commonly take evidence from the more important of their industries and from sponsor Departments and have access to MMC reports and the industries' annual reports it would be beneficial for them to question the industries on the action they have taken in response to specific criticisms; and that while we believe that no one area of an industry should be subject to an MMC investigation more frequently than every 4 years, the time has now come to consider re-references, and greater Select Committee interest in MMC reports could therefore fulfil a dual purpose in enhancing follow-up and helping to identify areas where a re-reference would be useful.
- 3. Mr Higgins accepted these points, welcomed the suggestion and undertook to speak to the relevant Select Committee Chairman.
- 4. I am copying this letter to the Private Secretaries to the Prime Minister, Members of E(NI), the Lord Privy Seal and Sir Robert Armstrong.
