Thank you for sending me copies of your letters of 21 June to Willie Whitelaw and Nick Edwards about your consultation meetings, especially those in early July, and your proposals for publicity about them. I am grateful to you for taking into account my officials' comments on the draft press release.

You and other colleagues may wish to know that our present thoughts in Scotland are to have a fairly large consultation meeting in Edinburgh in the autumn to cover all sectors of interest in primary care, including consumer representation: this will probably be followed up by a smaller meeting in a rural area.

I was interested to see your proposed advertisement encouraging people to apply for a copy of the leaflet summarising the contents of the discussion document. have encouraged Health Boards to make this leaflet widely available in NHS and other premises to which the public have access; we shall not be undertaking a separate advertising campaign along the lines you have in mind. Could I ask, however, that when the DHSS advertisement is placed in newspapers etc, it is not placed in newspapers which are Scottish-based - as distinct from those with a significant sized Scottish circulation - since the English address to which to apply for the leaflet could be confusing to Scottish readers. The leaflet is, of course, a UK document and does include a Scottish Home and Health Department address to which comments may be sent.

Thank you for the invitation to attend your July meetings at the Elephant and Castle about proposals for family doctors. I see from the draft press release that proposed dates are 14 and 21 July. I am afraid that neither John MacKay nor I will be able to come. I should, however, like SHHD officials to be present as observers and I am sure that this will not cause you any difficulty.
